Incoming first-year students may bring in a maximum of the equivalent of eight Gustavus courses (32 semester or 48 quarter credits). Transfer students and students who have earned an associate degree may bring in a maximum of 17 courses.

Transferrable coursework must come from a regionally accredited higher education institution and be appropriate for a college liberal arts curriculum. Only coursework graded C- or better is transferrable; credit will be granted only upon receipt of an official transcript from the host institution.

Transfer credit may fulfill Gustavus graduation requirements or count as electives, subject to the approval of the Registrar. Courses may also fulfill requirements for a major, subject to the approval of the appropriate academic department.
