If you have already paid your dues, thank you for your promptness! Pastors who participate in Pastor-2-Pastor get the greatest benefit from fully participating in all aspects of the program. If you choose not to participate in one aspect, the membership fee is not pro-rated accordingly. (Full cost of the program is about \$700 per pastor per year; fundraising makes up the difference.)*

Listed below are the expectations of membership in Pastor-to-Pastor:

- The commitment involves annual dues of \$150 per pastor for 12 months, whether coming on board in January or anytime later in the year. This program fully involves continuing education, and many pastors use their Continuing Ed funds for this purpose.
- The commitment involves participation with an assigned colleague team. Meetings are led by a trained facilitator and usually held monthly for about 2½ hours each time. The expectation is that you will network and share with a small group of pastors; check in and share joys and concerns; worship and pray together; study; discuss shared issues of ministry concern; set goals; and share “progress reports.”
- The commitment includes gatherings at Gustavus for 24-hour retreats or Sabbath, with pastoral continuing education provided. Held three times a year, these gatherings include worship, study sessions with academicians and others, and free time for discussion and informal conversation with a larger group of pastors. Each gathering has a different theme, and the intention is to provide a time of growth, reflection and renewal. Our interest is in wholeness and health of the pastor, with the belief that healthy congregations are served by healthy pastors
