### Old Business:

- Could you offer both options?
- Budget they asked about shipping.
  - Varies depending on the specific item (\$7, \$11, etc).
  - They order what they like and it ships to their house and then Gustavus would have to pay for the shipping.
- Can we support local businesses?
  - Challenges with tax laws concerning gift cards.
- 1 yr/3 yr recognition: Length of service awards cannot be within first 5 years due to tax laws.
  - But could still do recognition (like frost-your-own).
- There was discussion at that group could try something different and always go back. That group was asked to come up with their own ideas.
- Status right now: 3.3/3.4 group are having discussions.

#### **New Business:**

- There is an Administrative professionals day in April is there a way to do that at the institutional level for more groups to show you're appreciated (like Custodians).
  - Would be nice to have acknowledgement. Thanks for everything that you do.
