#### **Text**

<u>Financial Accounting, /Seventh Edition, by Kimmel, Weygandt and Kieso, 2013, Wiley.</u> Students will need access to <u>WileyPLUS</u> which comes with the book if you buy your book from the Gustavus bookstore. Otherwise you will have to purchase WileyPLUS separately.

## **Course Overview**

The course is designed to give you an understanding of the language of business. Regardless of your major you will benefit from an understanding of the basic financial statements and the basics of financial analysis. The more specific course and learning objectives are covered in each chapter of the textbook. The course will also develop your computer skills and your ability to work in small groups.

#### The Classroom

We will typically spend one day discussing the chapter and two or three days working on questions, exercises and problems. We will have either a group or individual quiz on most chapters. I expect to have good class participation and I hope that all of us will enjoy the class periods.

I will have a seating chart mainly to help me learn your names. I will jot down the date under your name if you are missing from class. I expect you to be in class and I will consider attendance in borderline situations. I don't anticipate that attendance will be a problem.
