Patricia Lindell Research Prize

Established in 1983 as the Patricia Lindell Award, in honor of the former First Lady who was the founder and first president of Gustavus Library Associates. It was awarded beginning with the 1983–84 school year to an upperclass student for a research project of potential benefit to Folke Bernadotte Memorial Library or the College. Effective with the 2003–04 academic year, the award alternates annually between this prize for an outstanding research paper as determined by the library selection committee and a scholarship announced in the fall that includes a project to be carried out during the academic year under the supervision of library staff.

Holcomb, former chief of staff at Bethesda Lutheran Medical Center in St. Paul. Additional funds are provided by the Sigma Xi-Albert G. Swanson Fund, which was established as the seed for an undergraduate research fund in 1971 by Martha M. Swanson to honor her husband, the longtime mathematics professor and academic dean at the College (taught 1947–1969). In 1998, members of the Swanson family made additional contributions to recognize their mother and to encourage quality student research in the natural and behavioral sciences.

Endowed and Restricted Scholarships

As it honors student achievement, Gustavus Adolphus College also recognizes the importance of the many donors who have provided scholarships to assist students with financial need. The College appreciates their generosity and publicly extends its gratitude for their support. With the exception of a few aid awards determined by outside organizations or governing bodies (e.g., the Thrivent Financial for Lutherans Foundation Lutheran College Scholarships), scholarships listed on the following pages are assigned to students by the College's Office of Financial Aid according to the students' academic standing, potential, and demonstrated need, in keeping with the intentions of the donors.

Erik and David Aasen Memorial Scholarship

Endowed scholarship established in 1996 by Paul Aasen, retired director of student financial assistance (1978–1999), and Nita Aasen (nursing faculty 1978–1987), parents of Erik and David, to honor the memory of their sons and to provide financial assistance to junior or senior students who demonstrate leadership qualities, have high academic standards, and are committed to entering the teaching profession, or who demonstrate the qualities necessary for admission to physical therapy school. Selection preference is given first to graduates of Blue Earth (Minn.) Area High School, second to St. Peter Senior High School, and third to candidates who meet the other criteria previously listed and who are from other schools.

Aasen Family Scholarship

Endowed scholarship established in 2005 with a gift from Paul Aasen, former director of financial aid at Gustavus (1978–1999), and his wife, Nita, instructor of nursing at the College (taught 1978–1987), to provide assistance to students who demonstrate financial need and who maintain an academic record that places them in the top half of their collegiate class.

W. Vincent and Pauline Abrahamson Scholarship

Endowed scholarship established in 1995 by W. Vincent Abrahamson '39. It provides financial assistance to students at Gustavus who are pursuing careers in the field of medicine as physicians and/or researchers, in the field of nursing, and in the field of medical technology.

Arthur and Amy Adamson Scholarship

Originally established in 2007 as an annually sustained scholarship funded for four years by Mark Scharmer '77 in honor of Art '51 and Amy (Wampler '54) Adamson. Art, who retired in 1995 after a 40-year career at Federated Insurance of Owatonna, had hired Scharmer upon his graduation from Gustavus and was an early mentor. In 2009, in consideration of gifts by Scharmer and other friends of the Adamsons', a scholarship endowment was created, with the first award made for the 2010–11 academic year.

Denny Aguiar Scholarship

Endowed scholarship established in 2012 with cash gifts by Dennis J. Aguiar '67, Leawood, Kan., "in honor of legendary coach Don Roberts (served 1959–1997), who recruited, coached, and mentored Aguiar during his four years at Gustavus and continues to be a lifelong friend." It is designated for students "who are well-rounded individuals as a result of their involvement in co-curricular activities."

Hazel and Gunnar M. Ahlquist Scholarship

Endowed scholarship created as a lasting tribute to Gunnar and Hazel Ahlquist; Gunnar graduated from Gustavus in 1924 after immigrating to America. Scholarships are to be awarded by the College, giving priority to immigrants or children of first-generation immigrant families.

Pastor Joel D. Albers Memorial Scholarship

Endowed scholarship established in 1999 in memory of the Rev. Joel Albers '92 by his parents, the Rev. Robert and Sonia Albers, to remember his years as a student leader at Gustavus, his love for the College, and his commitment to ministry. The scholarship also honors the ministry of the Rev. Dennis Johnson '60, who was a mentor, confidant, friend, and role model for Joel. It is designated for students preparing for a life of ministry—lay or ordained. To reflect Joel's passion for social justice and issues of equality, students of color and/or women are given preference.

Lois and Clyde Allen Scholarship

Endowed scholarship established by Clyde Allen, a 1956 graduate of Gustavus who served the College's Board of Trustees nearly continuously between 1982 and 2000, and his wife, Lois Madsen Allen '59. The first award was made for the 1988–89 academic year.

Alliss Education Foundation Scholarship

Annually sustained scholarships selected by Gustavus and restricted to students in the top 40 percent of their classes, with preference given to residents of Minnesota.

Charles and Ellora Alliss Endowed Scholarship

Endowed scholarship donated by Charles and Ellora Alliss and selected by Gustavus.

Almen-Vickner Foundation Scholarship

Endowed scholarships selected by Gustavus, with preference given to the descendants of the Almen and Vickner families, more than 100 of whom have attended to date. This scholarship recognizes the legacy of family members who attended or were active at Gustavus, including L.G. Almén (served on the Board of Trustees, 1902–1908); Alma O. Almén (taught 1902–1903); Victoria Almén Towley 1899; G. Theodore Almén 1904 (taught 1904–1906); Ansgar L. Almén 1910 (served on the Board of Trustees, 1944–1950 and 1951–1960); and Bertha Almén Vickner 1910 and her husband Edwin J. Vickner (taught 1903–1912 and 1950–1951), who in 1945 were the first recipients of the Gustavus Alumni Association's Greater Gustavus Award for "exceptional service to the College."

Fred J. Anderholm Scholarship

Endowed scholarship established as a memorial to Fred J. Anderholm '42 and to honor his career as a businessman. The scholarship is designed to encourage initiative and a spirit of entrepreneurship through financial assistance for an economics major.

David L. Anderson Scholarship

Endowed scholarship established in 2005 with a gift from the estate of David Anderson '75, and additional gifts from friends and family and first awarded for the 2006–07 school year. David contended with multiple sclerosis for his entire adult life, and following his death in 2003 his estate gift became a legacy of the generosity he had exhibited in life.

Professor George W. and Edith M. Anderson Scholarship

Endowed scholarship established in 1976 in honor of longtime English professor George Anderson '24 (taught 1937–1974) and his wife, Edith M. (Carlson '27) Anderson.

George Anderson and Elmer Suderman Scholarship

Endowed scholarship established in 2010 with a gift from Nick '71 and Yonok Zeller, in appreciation for two longtime members of the Department of English—George Anderson (taught 1937–1974) and Elmer Suderman (taught 1960–1986, and part-time through 1998 as a research professor)—to be awarded to students majoring in English for their junior year at the College.

Lavinia, Gustav, and Rubert Anderson Scholarship

Endowed scholarship established in 1975 by Rubert S. Anderson, biologist at Woods Hole and longtime benefactor of the College, in honor of his parents, Lavinia and Gustav Anderson. This scholarship was combined with the Rubert S. Anderson Scholarship in 1979 and is designated for biology/physiology majors.

Mabel L. and Nils G. Anderson Scholarship

Endowed scholarship established in 1995 through the bequest of Mabel L. Anderson, honorary member of the Class of 1928, to provide financial assistance to Gustavus students, preferably to students who are planning to become ministers in the Lutheran church. This scholarship honors the memory of Mabel L. Anderson and her husband, Nils G. Anderson '28.

Marion O. “Andy” and Margaret R. Anderson Scholarship

Endowed scholarship funded in 2002 with the remainder amount of an annuity trust established in 1988 by friends of the College Andy Anderson and his wife, Margaret, and first awarded for the 2005–06 academic year to Minnesota students who desire a Gustavus education.

Oscar Anderson Scholarship

Endowed scholarship established in 1976 through a major bequest by Oscar V. Anderson, friend of the College.

Verna Leona Anderson Scholarship

Endowed scholarship established in 1985 through the will of Verna Anderson of Fort Ripley, Minn., a teacher who had lived and worked in New York, and designated for deserving women students.

Barbara Andrews Scholarship

Endowed scholarship established in memory of the Rev. Barbara Andrews '58, to be used especially in support of students with disabilities.

Annexstad Family Foundation Scholarship

Endowed scholarship established in 2000 by Albert T. Annexstad's family foundation to benefit young men and women who have matured through the Big Brothers/Big Sisters program and who desire a Gustavus education. Priority is given to high-need students from Steele, Nicollet, Blue Earth, Dodge, and Rice counties in southern Minnesota. Scholarships are renewable for each of the four years that the selected students are enrolled.

Jessie Gustafson Araskog Scholarship

Endowed scholarship established in 1997 by Jessie Gustafson Araskog '56 and first awarded for the 2005–06 academic year. The fund provides scholarships to undergraduate students whose permanent residence prior to attending Gustavus Adolphus College is in the state of Minnesota and who graduate from public high schools in cities and towns with populations under 50,000.

Abner W. and Una M. Arthur Scholarship

Endowed scholarship established in 1997 and named for the Rev. Abner Arthur '31 and his wife, Una (Anderson '31) Arthur. “Abbie” Arthur served on the College's Board of Trustees, as vice president of church relations, and as interim president of the College twice. He played a significant role in the building of Christ Chapel. The scholarship is awarded to students majoring in humanities.

Augustana Theological Scholarship

Endowed scholarship selected by Gustavus but restricted to students of ELCA membership who exhibit strong character, interest in the Church, and potential Christian leadership.

Bahl Foundation Scholarship

Annually sustained scholarships established in 2007 by the Bahl Foundation and funded with annual gifts for two incoming students for a four-year period, with preference for students “who have financial need, a solid GPA, and are well-rounded individuals as a result of their involvement in co-curricular activities.” The scholarships, first awarded for the 2006–07 academic year, are given by Tracy Bahl '84, a member of the College's board of trustees since 2006, and Penny Bahl Bailey '87, out of gratitude for their Gustavus experiences and education and in memory of their father, Wesley Bahl.

Erich Martin Bahr Scholarship

Endowed scholarship established in 1999 by Erich Bahr's daughter, Virginia Bahr Nystrom, to honor his Lutheran upbringing and his success as a businessman. It is awarded annually to two junior or senior students, one of each gender. The recipients are selected by the College, with preference given to “students in the areas of art and/or business to reflect Mr. Bahr's background.”

Edwin and Phyllis Bakke Scholarship

Endowed scholarship established in 2000 by Phyllis E. Bakke, former Honorary Consul of Sweden for the State of Minnesota, in memory of her husband, Edwin, to encourage students with financial need to attend the College.

Batzli Scholarship

Endowed scholarship given by Otto Batzli, a friend of the College, to honor the Batzli family.

Alice A. Bayer and Marlene J. Bayer Music Scholarship

Endowed scholarship established in 1993 by Alice A. Bayer '41 as a permanent expression of the interests and careers in music of two sisters, Alice A. Bayer '41 and Marlene J. Bayer '48, to provide financial assistance to a junior or senior student majoring in music.

Russell and Ruth Beck Scholarship

Endowed scholarship established through the will of Russell Beck of St. James, Minn., in 1994 to provide scholarship assistance to students preparing for the ministry.

Victor E. Beck Scholarship

Endowed scholarship established in memory of Victor Beck, a 1914 graduate, by his family.

Beck-Proft Nursing Scholarship

Endowed scholarship established in 1972 in honor of Martin and Agnes Beck-Proft, parents of Professor Emerita Ruth Dannehl (taught 1967–1983), and awarded to upperclass nursing students, as recommended by the faculty.

Noel D. and Frances C. Behne Scholarship

Established in 2003 by Noel Behne, Class of 1958, to provide financial aid to students majoring in business administration or education, with preference given to Minnesota students from high schools in Jackson and Martin counties.

Jennifer Beilgard Memorial Scholarship

Endowed scholarship established in 2008 by two Gustavus history professors, Gregory Kaster and Kate Wittenstein, to celebrate the spirit and curiosity of Jennifer Beilgard, who died in a car accident during her first year at the College. First awarded for 2012–13, preference is given to first-year women or minority students “whose school or community involvement best recalls the activism of the 1960s on behalf of peace, justice, and the rights of minorities.”

Bendemar Scholarship

Originally named the Henry N. Benson Jr. and Gloria E. Martell Benson Scholarship, this endowment fund was established by Gloria Martell Benson '50 and named after her and her husband, Henry N. Benson Jr. '37. Renamed in 1998, the scholarship honors the legacy of the Benson and Martell families at Gustavus, who were enrolled at the College during every decade between the 1890s and 1970s.

Henry Benson Sr. Scholarship

Endowed scholarship established in honor of this distinguished member of the Class of 1893 and longtime member of the Gustavus Board of Trustees (served 1902–1944) by his family.

E. Irving and Helen A. Bergeson Scholarship

Funded in 2003 by E. Irving Bergeson, Class of 1935, and his wife, Helen A. Bergeson, with the remainder of an annuity established in 2000, so that students might receive the same “liberal arts education that gave them a fine jump start in making the many adaptations that have confronted them in life.” First awarded in 2009–10, preference is given to students “who have achieved a ‘B’ average or higher and who have demonstrated themselves to be hard working, moral, and ethical students who have a strong desire to avail themselves of the advantages of a liberal arts education.”

Anders G. and Mathilda Bergren Scholarship

Endowed scholarship established by the Bergren family and designated for students preparing for the Lutheran ministry.

Bergstrand-Owens Scholarship

Endowed scholarship established in 1984 in honor of Emery Owens and the Bergstrand family by Evalyn Bergstrand Owens, friend of the College.

Count Folke Bernadotte Memorial Scholarship

Established in 1950 as a memorial to Count Folke Bernadotte, the endowed scholarship has been awarded annually to international students.

Bernhardson Family Scholarship

Endowed scholarship established in 1992 by Adeline and the Rev. Drell Bernhardson, parents of Gustavus graduates Carol '68, Mark '71, John '76, and Paul '81 Bernhardson, to provide encouragement and financial assistance to qualified Gustavus students.

Richard and Eunice Backen Blomberg Scholarship

Endowed scholarship established in 1983 by Eunice Backen Blomberg '38 and her husband, Richard, and further funded with a legacy gift in 2003, with preference given to students from foreign countries (especially Africa), Muslim students from foreign countries, American Blacks or other minority students, or students with special needs.

Arlene Hanson Bloom Scholarship

Endowed scholarship established in 2005 with gifts from John Bloom, husband of Arlene Hanson Bloom, Class of 1953, one of the first female business majors at Gustavus. The scholarship is awarded with preference given to women with majors in the Department of Economics and Management.

Ross F. and Lavinia C. Bloomquist Scholarship

Endowed scholarship established in 1995 with annuity agreements between the Bloomquists and the College, and supplemented with subsequent gifts from friends and relatives. Ross Bloomquist '45 retired as vice president of finance and treasurer of Gustavus after 42 years' service in the business office (1946–1988); he died in 1998. His wife, Lavinia (Bloom '45), was a registered nurse and taught nursing at Gustavus and Mankato State University.

Dr. Daniel and Eleanor V. Boda Scholarship

Endowed scholarship established in 2000 through a gift from Daniel and Eleanor Boda, friends of the College who both taught at Furman University in Greenville, S.C. It is designated for junior or senior students preparing for ordained or non-ordained service in the Lutheran Church or Lutheran congregations.

Boulay, Heutmacker, Zibell & Co. P.L.L.P. Scholarship Dedicated to the Memory of Nick Greve

Annually sustained scholarship established in 2010 by the accounting firm of Boulay, Heutmacker, Zibell & Co., which employs a number of Gustavus graduates, and dedicated to the memory of Nick Greve '07, who had worked for the firm. Preference is expressed for students majoring in accounting, who have a cumulative GPA of 3.0 or better.

Bowers Family Scholarship

Endowed scholarship established in 2007 by Brian Bowers '87 and designated for students from rural towns and cities in southern Minnesota.

Breckner Family Scholarship

Endowed scholarship established in 2007 by the Breckner family—Jane Breckner Pederson '81, Paul '82 and Susan (Erlandson '83) Breckner, Bill Breckner, and their parents, Ron and Judy Breckner—and designated first for students from Polk and Burnett counties of northwestern Wisconsin and then for students who have an interest in economics or business.

Dr. Gerald W. Brekke Scholarship in Education

Endowed scholarship established in 1996 by the family of Gerald W. Brekke in recognition of his service to the Department of Education Department (1962–1987), including three terms as chair of the department. This scholarship is awarded to students majoring in education for whom financial aid is essential in order to permit their attending Gustavus Adolphus College. Secondary preferences are students from rural areas (fewer than 10,000 population), with students from North Dakota who meet the other criteria receiving preferred status.

Esther L. Brink Scholarship

Endowed scholarship established in honor of Esther L. Johnson Brink '32, by her husband, Lyman Brink.

Robert C. Byrd Honors Scholarships

A federally funded scholarship awarded competitively to outstanding high school graduates for their first year of study at a post-secondary school and renewable for up to three more years.

Calbeck Scholarship

Endowed scholarship established in 1991 by Elnore Calbeck, a friend of Gustavus Adolphus College.

Cargill Foundation Scholarship

Awarded through the Minnesota Private College Fund, with preference given to students of color with the stipulation that recipients attend at least one Cargill-sponsored event annually. Cargill is an international marketer and processor of agricultural, financial, and industrial products.

The Rev. A. Wallace and Anne L. Carlson Scholarship

Endowed scholarship established in 1999 by gifts from the Rev. A. Wallace Carlson '37, his wife, Anne, and their children, Marta Carlson Gisselquist '73, Mark '77, Kent, and Vicki. Given in appreciation of and gratitude for the College, its intent is to provide encouragement to young men and women who desire a Gustavus education.

Curtis L. Carlson Swedish American Scholarship

The Curtis L. Carlson Foundation established an endowment fund at the American Swedish Institute, Minneapolis, which provides income to Gustavus allowing students from either Lund University or Uppsala University in Sweden to attend up to two semesters at Gustavus.

Ebba Edquist Carlson Biology Scholarship

Endowed scholarship established in 1986 by Edgar M. '30 and Ebba (Edquist '31) Carlson, president and first lady of the College from 1944 to 1968, in her honor, to be awarded to students with a major interest in biology.

Edgar M. and Ebba E. Carlson Scholarship

Endowed scholarship established in 1992 by Edgar M. Carlson '30, who served as president of Gustavus for 24 years.

Roger and Janet Carlson Scholarship

Established in 1998 by Roger '54 and Janet (Christenson '53) Carlson, this endowed scholarship is designed to provide encouragement to young men and women who desire a Gustavus education and for whom financial aid is essential. Recipients are selected by the College, with preference given to students majoring in economics and management and who participate in co-curricular activities.

Theodore L. and Henrietta B. Carlson Scholarship

Endowed scholarship established in 2005 with the assets from the estate/trust of Theodore and Henrietta Carlson given to the College by their niece Shirley Huskins. Theodore Carlson, a graduate of the University of Minnesota who worked with a number of railroad companies as an electrical engineer, and his wife had been familiar with Gustavus through several nieces, nephews, and cousins who attended, and the donor indicated that the scholarship be awarded with preference given to students who, like Mr. Carlson, are from the rural areas of central Minnesota.

Centennial Class of 1962 Scholarship

Endowment established in 2002 to carry on the legacy of the class that holds the distinction of graduating during the 100th anniversary year of the founding of Gustavus. Members of the Centennial Class of 1962 encouraged each other to begin this scholarship with sufficient gifts so the first recipient could be identified by the time of their 40th anniversary reunion in September 2002. The scholarship is intended to provide support and encouragement for generations of women and men who desire a Gustavus education.

Herbert and Corinne Chilstrom Scholarship

Endowed scholarship established in 1998 by the Rev. Dr. Herbert Chilstrom, former bishop of the ELCA, and his wife, the Rev. E. Corinne Chilstrom, to support students who need financial assistance to attend Gustavus. Preference is given to students who are pre-seminary.

John Chindvall Scholarship

Endowed scholarship established in memory of 1970 graduate John Chindvall by his parents and friends and designated annually for a student majoring in physics.

Dr. Jack Lowell Clark and Esther Strege Clark Scholarship

Endowed scholarship established in 2005 with gifts by Rebekah Clark Forsyth Sousa from the estate of her uncle and aunt, Jack Clark '52 and Esther (Strege '53) Clark. The scholarship is designated for "outstanding students pursuing studies in classics, religion, or music."

- the Class of 1952 Scholarship, established 2002 to mark their 50th and active 2010–11;
- the Class of 1953 Scholarship, established 2002 to mark their 50th and active 2003–04;
- the Class of 1954 Scholarship, established 2008 in anticipation of their 55th and active 2010–11;
- the Class of 1955 Scholarship, established 2005 to mark their 50th and active 2007–08;
- the Class of 1956 Scholarship, established 2004 in anticipation of their 50th and active 2007–08;
- the Class of 1957 Scholarship, established 2006 in anticipation of their 50th and active 2008–09;
- the Class of 1958 Scholarship, established 2008 to mark their 50th and active 2009–10;
- the Class of 1960 Scholarship, established 2007 in anticipation of their 50th and active 2010–11;
- the Class of 1961 Scholarship, established 2005 to mark their 45th and active 2010–11;
- the Centennial Class of 1962 Scholarship, to mark their 40th anniversary (see separate entry above);
- the Class of 1963 Scholarship, established 2002 to mark their 50th and active 2004–05;
- the Class of 1964 Scholarship, established 2004 to mark their 40th and active 2007–08;
- the Class of 1966 Scholarship, established 2005 to mark their 40th and active 2012–13;
- the Class of 1980 “Edward and Patty Lindell” Scholarship, first established in 1980 by that class in honor of outgoing president Edward Lindell (served 1975–1980) and his wife, Patricia, and combined in 2010 with a class scholarship; active 2002–03;
- the Class of 1981 Scholarship, established 2011 to mark 30 years and active 2012–13;
- the Class of 1982 Scholarship, established 2008 to mark their 25th and active 2008–09;
- the Class of 1983 Scholarship, active 2012–13.

Class of 1920 String Instrument Scholarship

Endowed scholarship established in 1985 by members of the Class of 1920 to “encourage excellence in the study of stringed instruments at Gustavus.” It was initiated in 1970 (the class’s 50th anniversary year) as a savings account, supported by Class of 1920 members and many other alumni and friends of the College. It is available exclusively for players of stringed instruments.

Class of 1952 Scholarship in Memory of Seifu and Garmame

Endowed scholarship established in 2008 by the Class of 1952 in memory of two classmates from Ethiopia, Garmame Wondafrash and Seifu Selassie, both of whom were martyred during ongoing political violence in their homeland during the 1960s. First awarded in 2009–10, it is designated for “students who bring diversity to campus, with preference for African American students.”

Sarah Cofield Scholarship

Endowed scholarship established through the will of Sarah Cofield, friend of the College, to provide funds for Lutheran higher education, specifically, preparation for service in the Church.

Titus A. and Antonia M. Conrad Scholarship

Endowed scholarship established in 1948 by the Rev. Titus A. Conrad, a 1901 graduate, and his wife, Antonia, in tribute to the Rev. Matthias Wahlstrom, former president of the College. The scholarship is awarded annually to a senior Lutheran pre-theology student chosen on the basis of character, scholarship, aptness for service in the Gospel ministry, and general achievements while in college.

James Corda Scandinavian Studies Scholarship

Annually sustained scholarship funded in 2005 for four years in memory of James Corda ’82 as a “celebration of his life and love of learning.” It is designated for students pursuing a major or minor in Scandinavian studies.

Corundum Scholarship

Annually sustained scholarship established in 2011 for a four-year period by Ron Johnson ’81 through the Corundum Foundation, with preference given to students interested in studying the history of business.

Mildred Peterson Cue Music Scholarship

Endowed scholarship established by Mildred Peterson Cue ’24, and awarded to students of sophomore status or above who are proceeding with distinction toward a degree in music with a concentration in piano.

The Charles and Kathryn Cunningham and Greg and Kim (Barron) Cunningham Scholarship

Endowed scholarship established in 1999 through gifts from Charles Cunningham, a member of the College’s board of trustees (1998–2002), and his wife, Kathryn, and from their son, Greg ’87, and his wife, Kim Barron Cunningham ’88. It supports students “who exhibit evidence of hard work, character, ambition, energy, and perseverance that may not be measured through standardized tests taken in high school or even in class rankings.” Special consideration is given to students whose performance during their first year(s) in college indicates strong promise and commitment irrespective of their relative standing at admission to the College.

Edith L. Dahlin Scholarship

Endowed scholarship established in 1973 through the will of Edith Dahlin ’29.

G. Maynard Dahms Scholarship

Endowed scholarship established in 1976 by family and friends in memory of G. Maynard Dahms ’31.

Howard R. Davis Scholarship

Endowed scholarship established by Dorothy Davis in memory of her husband, Howard R. Davis '49; designated to assist students studying in the field of mental health.

Rodney O. and Jacqueline S. Davis Scholarship

Endowed scholarship established in 1996 by Professor Emeritus Rodney O. Davis to recognize both his Gustavus career (taught 1953–1990) and the lifelong hospitality that his late wife, Jacqueline S. Davis, extended to Gustavus students. The scholarship encourages excellent students in the spirit of the Partners in Scholarship program, with preference given to history majors, followed by majors in the humanities, the social sciences, or the physical sciences.

DeRemee Family Scholarship/Dag Hammarskjöld Award

Established in 2000 as part of the DeRemee Family Scholarship Endowment Fund by Richard A. '55 and E. Lucille (Fogelstrom '56) DeRemee. The Fund represents "an honor and memorial for members of the families DeRemee and Fogelstrom," who desire to maintain and foster strong ties between the College and its Swedish roots. The scholarship, named for the eminent Swedish statesman, is designated to help a Gustavus student study in Sweden or a Swedish student to study at Gustavus.

Directors Scholarship

Awarded annually starting with the 2001–02 academic year through the Minnesota Private College Fund (MPCF) to one Minnesota resident at each member college, with preference given to students of color who are Minnesota natives. The MPCF directors have made a commitment to support "deserving students who are the business, professional, and community leaders of tomorrow."

Dr. Hiram M. and Ada M. Nelson Drache Endowed Scholarship

Established in 2000 by Hiram Drache, Class of 1947, author and historian in residence at Concordia College, Moorhead, Minn., and by his wife, Ada Nelson Drache, Class of 1950, "to encourage learning"; first awarded for 2009–10, preference is given to students majoring in history or economics.

Duncan Family Scholarship

Endowed scholarship established in 2011 by Gregg Duncan '73 and his wife, Betsy Lee Duncan '73, with gifts from the Duncans, including gifts directed to the College from the estate of Betsy's father, Harold Dean Lee, as well as a bequest from their own estate. It was first awarded for the 2011–12 school year.

Joanell and Marvin Dyrstad Family Scholarship

Endowed scholarship established in 2007 with a gift from Joanell Sletta Dyrstad '64 and her husband, Marvin. Reflecting Joanell's service as three-time mayor of Red Wing, Minn., lieutenant governor of Minnesota (1991–1995), and member of hospital and health care boards at the local, state, and national level, the scholarship is designated for Minnesota students from outside the Minneapolis-St. Paul metropolitan area "who have exhibited citizenship and service in their lives."

Hugh A. Edmondson Jr. and Joyce D. Edmondson Scholarship

Endowed scholarship established in 1992 by Hugh A. Edmondson Jr. and Joyce D. Edmondson, friends of the College.

Annette R. Edquist Scholarship

Endowed scholarship established in 1984 through the will of Annette Edquist '27; it is designated for music students in piano, organ, or voice.

Hubert L. Edquist Scholarship for Vocal or Piano Students

Endowed scholarship established in 1992 by Edgar M. Carlson '30, president of Gustavus Adolphus College from 1944 to 1968, honoring Hubert L. Edquist '24, the son of longtime Gustavus professor Joshua Edquist (taught 1889–1930) and the brother of his wife, Ebba Edquist Carlson '31. This scholarship provides financial assistance to students in piano or vocal music.

Nell and Louis Eiffert Scholarship

Endowed scholarship established in 1998 by Jan Eiffert Hoomani '62 to honor her parents and reflect her own interest in education and teaching, and first awarded in 2001–2002. Priority is given to junior and senior students intending to enroll in the secondary education program in music, arts, English, and/or foreign languages, and for whom financial aid is essential in order to permit their attendance at Gustavus.

Henry and Anna Eiselein Scholarship

Endowed scholarship established in 1981 through a bequest from the Eiseleins, friends of the College.

John R. Ekberg Memorial Scholarship

Endowed scholarship established in memory of business major John Ekberg '62 of Minneapolis by his family and awarded annually to a junior or senior student in economics or management.

Gordon and Cecile Ellis Scholarship

Current scholarship established in 2010 with a gift from Gordon Ellis and his wife, Cecile Carlson Ellis '47, of Fargo, N.D. As a student, Cecile was very active in music, accompanying choirs and working in the Music Department, and subsequently the scholarship is designated for students majoring in music education.

Linda L. Elvee Non-Traditional Student Scholarship

Endowed scholarship established in 1995 by Linda L. Elvee '92 and supported by the founder and other alumni and friends of the College, to assist students with non-traditional backgrounds to start or to continue their education at the College.

Deborah Lynn Engel Memorial Scholarship

Endowed scholarship established in 1996 by Gordon Baxter as a way of perpetuating the memory of his wife, Deborah Lynn Engel '77, who died on Christmas Eve 1995. The Deborah Lynn Engel Memorial Scholarship also will be a reminder to their son, Colin, of the life of his mother, whose two years with him were a time of great dreams for his future. Memorial gifts from other family members and friends of Deborah Lynn Engel also are included in this endowment. This scholarship provides financial assistance to first-year students.

Lloyd and Frances Engelsma Scholarship

Endowed scholarship established in 1996 by friends in the construction industry honoring Lloyd Engelsma's leadership on the Gustavus Adolphus College Board of Trustees (served 1960–1995) and Frances Engelsma's leadership as a founder and member of the board of Gustavus Library Associates.

Arthur T. Erickson Scholarship

Endowed scholarships established in 1973 at Gustavus Adolphus College and Carleton College by Arthur T. and Elsie Erickson, friends of both colleges, with additional funding provided by their daughter, Marge Erickson Pihl, and her husband, former board chair Charles Pihl (served 1976–1982).

Cecelia D. Erickson Scholarship

Endowed scholarship established in 2010 with a bequest from Cecelia Erickson '64, who passed away in 2008. "CeCe," an English major at Gustavus, had a long career as a technical writer for Control Data and designated her scholarship for students majoring in English.

Irene Jacobson Erickson Memorial Scholarship

Endowed scholarship established in 1979 in memory of 1907 graduate Irene Jacobson Erickson by her children (all of whom are also Gustavus graduates) and grandchildren and first awarded in 1983–84, with preference to music majors.

Marjorie Erickson-Geisler Scholarship

Endowed scholarship established in 1998 in honor of Marjorie Erickson-Geisler '61 by her husband, James Geisler; it is to be awarded to first-year students for whom financial aid is essential in order to permit their enrollment at Gustavus and is then renewable for each year of their attendance. Recipients will be awarded a Gustavus ring in their senior year.

Federated Insurance Accounting Scholarship

Annually sustained scholarship funded with an annual cash gift and first awarded during the 2012–13 academic year. Preference is given to "students majoring in accounting, who have a cumulative GPA of 3.5 or higher, are in their sophomore, junior, or first semester of their senior year, and who have demonstrated community service or hold leadership positions in co-curricular activities."

Federated Leadership Scholarships

Annually sustained scholarships provided to seniors with grade point averages of 3.0 and above, with preference given to economics and management majors who have taken leadership roles in major-related work or internship experiences.

David Fienen Organ Scholarship

Awarded annually to incoming or current organ students at Gustavus in honor of Professor Emeritus David Fienen, for his 38 years of dedicated service to the College and its students. David inspired many students during his tenure at the College, instilling in them the desire to serve as church musicians and giving them a love of organ music as well as the training and tools they needed to work and excel. He influenced hundreds of other student musicians through his leadership with Christmas in Christ Chapel and by teaching numerous core courses in the Department of Music.

Steven Fink Scholarship

Endowed scholarship established in 1975 in memory of 1967 graduate Steven Fink by his family, Nu Upsilon Gamma fraternity brothers, and other friends, and restricted to upperclass students majoring in chemistry or biology.

First National Bank of St. Peter Scholarship

Endowed scholarship established in 1992 by the First National Bank of St. Peter, Minn., to provide financial assistance to a St. Peter student.

Verna B. and Tollie J. Flippin Sr. Scholarship

Endowed scholarship established in 2009 with gifts given in memory of Verna and Tollie Flippin Sr. and an estate gift by their children, Ardena '68, Tollie Jr. '71, and Marsha Flippin Davenport. "In support of diversity as one of the primary goals of Gustavus Adolphus College, and reflecting the spirit of Tollie and Verna's aspirations, this endowment is established to assist the recruitment and retention of African American students."

Founders Scholarship

Endowed scholarship made possible by grouping a number of smaller endowments provided by alumni and friends, including the Roger Arvidson Scholarship, Alice and Anna Beck Scholarship, Michael Brewster Memorial Scholarship, Swan Carlson Scholarship, Dr. E.C. Carlton Scholarship, Class of 1983 Scholarship, Charles W. Ehdy Scholarship, Ruth Lundgren Ernst Scholarship, Carl and Lillian Gulbrandsen Scholarship, Dag Hammarskjöld Scholarship, A. Edwin Johnson Memorial Scholarship, Jennie M. Johnson Scholarship, Viola Adele Johnson Memorial Scholarship, Alma Karstad Memorial Scholarship, Langsjoen Memorial Scholarship, O. Theodore Larson Scholarship, Victor Lawson Scholarship, Emma Lundeen Scholarship, Magney Scholarship, Edward N. Nelson Scholarship, Ralph Durwood Parsons Scholarship, L.R. Peel Scholarship, Joan Quanbeck Memorial Scholarship, Ryden Scholarship, William E. Seaberg Scholarship, Swedish Foundation Scholarship, Jean Marie Novack Toszek Scholarship, and Patty Woods Scholarship.

Marlyn Windedahl Franzen Scholarship

Endowed scholarship established in 2011 with a gift from his IRA by Kermit Franzen of Oregon, Wis., in honor and memory of his wife, Marlyn Windedahl Franzen '64, and active beginning 2012–13. Reflecting Marlyn's 36-year career in education in the Madison, Wis., school district, the scholarship is directed at students who are majoring in elementary education.

Randall Frerichs Scholarship

Endowed scholarship established in 1983 by Donald and Dianne Frerichs and friends in memory of their son, Randy, a student who died in 1982 and was awarded a degree posthumously in 1984.

Robert and Mary Lindholm Fricker and John Fricker Memorial Scholarship

Endowed scholarship established by Mary Lindholm Fricker '42 and Robert Fricker, parents of John Fricker, whose degree was awarded posthumously in 1975. The scholarship, which now also honors the memory of Robert and Mary Fricker, is designated for a junior or senior in pre-law studies, as recommended by the political science and history faculties.

Gamble-Skogmo Scholarship

The Gamble-Skogmo Fund of the Minneapolis Foundation provides scholarships for students through the Minnesota Private College Fund. The mission of the B.C. Gamble and P.W. Skogmo Fund is “to attract and mobilize the community and philanthropic asset resources needed for every individual, family, and community in Minnesota to reach full potential.”

Gamble and Skogmo Foundations Scholarship

Scholarship made possible by an endowment from the combined foundations and awarded annually to an upperclass student or students in economics or management.

Lisa R. Gault Scholarship

Annually sustained scholarship first funded in 2006 for four years by Lisa Gault '83 and renewed for four more years starting in 2011, to be awarded according to the criteria and processes of the Jussi Björling Music Scholarships.

Dr. Robert K. and Alecia A. Gazzola Scholarship

Annually sustained scholarship established in 2011 by Dr. Robert Gazzola '83, a family practitioner in St. Peter who oversees the Gustavus Health Services and works closely with student-athletes, and his wife, Alecia Tromiczak Gazzola '98, a two-time NCAA Division III All-American in soccer and a former admission counselor for Gustavus. It was first awarded for the 2011–12 school year. The donors intend that preference in awarding the scholarship be given to “sophomore, junior, or senior students majoring in biology, or who are pre-med, and who are well-rounded as a result of their involvement in extra-curricular activities.”

Emily J. Gentholts Scholarship

Endowed scholarship established in 2007 with gifts from the Gentholts family and friends in memory of Emily, an environmental studies major from Montana who died in June 2007 and was awarded her degree posthumously in September 2007. To honor her memory, the scholarship is designated for an out-of-state female student studying chemistry or environmental science, with preference given to candidates involved in extracurricular activities and charitable causes.

Good Samaritan Scholarship

Endowed scholarship established in 2000 by an anonymous donor and designated for students of promising academic ability who also have special, extenuating circumstances in their families such as sudden death, serious illness or disability of a parent or provider, or other health issues that create difficult financial circumstances. The Good Samaritan Scholarship may be used to extend the recipients' calculated aid awards.

Harold and Marvel Granberg Scholarship

Endowed scholarship established in 1999 by Donald Granberg '63 in memory of his father, Harold, and his mother, Marvel. It is intended to “encourage young men and women who are considering a Christian vocation.”

Paul T. and Edna Spaeth Granlund Scholarship

Endowed scholarship established in 2005 through gifts made in memory of Paul Granlund '52, sculptor-in-residence at the College from 1971 to 1996, and additional gifts from his wife, Edna Spaeth Granlund '50. In recognition of Edna's own nurse training and the tradition of nursing in her family—her mother, Alice Ostrom Spaeth '16 was an army nurse, and her daughter, Gretchen Granlund Musicant, has served in the public health field as health commissioner for the city of Minneapolis—the scholarship is designated for students studying nursing.

Bruce and Sue Gray Scholarship

Endowed scholarship established in 2004 by Bruce Gray, Class of 1961, who served the College for more than 40 years in admissions and financial aid, as dean of students, and most recently in gift planning, and by his wife, Sue. It is their intent that the scholarship be awarded to students for whom financial aid is essential in order to permit them to attend Gustavus, with preference given to students similar to those who qualify for the Paul Rucker Scholarship. It was first awarded in 2008–09.

Greater Gustavus Scholarship

Endowed undesignated scholarship established in 1994 with an initial gift of \$1.5 million from the Greater Gustavus Fund, which was originally incorporated on March 16, 1927, as the Greater Gustavus Endowment Corporation to “aid and assist in providing endowment for Gustavus . . .” (Its name was changed in November 1945 to reflect an expanded mission “to further the interests of Gustavus.”) In addition to scholarships, the Greater Gustavus Fund has supported nearly every major Gustavus initiative, starting with its first gift for the Myrum Memorial Fieldhouse in 1939, and including a portable pipe organ, early computer equipment, the Swanson Tennis Center, Lund Center, Curriculum II, communications and writing labs, Nobel Hall, Linnaeus Arboretum, Christ Chapel and the Church Retreat House, Jackson Campus Center, the Old Main renovation, and the Kendall Center for Engaged Learning.

Gustavus Adolphus College Association of Congregations Scholarship

Approved by the Gustavus Adolphus College Association of Congregations at its annual meeting and established as an endowment in 1989, the funds provide scholarship monies to deserving students from member congregations.

Gustavus II Adolphus Society Scholarship

Endowed scholarship selected by Gustavus and designated for students who are “related to or descendants of members in good standing of the Gustavus II Adolphus Society,” a society established in 1886 by 12 Swedish immigrants.

Haber Olson Scholarship

Endowed scholarship established in 1989 by James and S. Lenore Anderson Haber '51. John Olson, Lenore Haber's great-grandfather, was one of 11 students who attended Eric Norelius's school (the forerunner of Gustavus Adolphus College) in Red Wing, Minn., in 1862.

“Ginger” Froyen Haddorff Scholarship for Study Abroad

Endowed scholarship established in 1997 by Virginia “Ginger” Froyen Haddorff ’67. Her husband, Bob Haddorff ’67, is also a graduate, as are their two sons, Ryan ’95 and Benjamin ’98, who represent the fourth generation of her family to study at Gustavus. The purpose of the scholarship is to enable Gustavus students to study abroad, especially those who do not normally consider overseas study.

George and Lorena Hall Family Scholarship

Annually sustained scholarship first awarded in 2002–03 and recognizing religion professor George Hall (taught 1938–1956) and his family; it is intended for “those who may not qualify for other scholarships.”

Carl Axel Hallberg Scholarship

Endowed scholarship established through the bequest provision of Carl Axel Hallberg, Class of 1910, a resident of Canada.

Violet Halvorson Scholarship

Endowed scholarship established in 1990 with a bequest from the estate of Violet E. Halvorson, a friend of Gustavus Adolphus College.

Charles L. Hamrum Scholarship

Endowment established in 1981 in honor of the late biology professor and member of the Class of 1947 (taught 1949–1988) by a group of his former students who had followed him into the field of entomology, for his contributions to and influence on their careers. The scholarship is designated for an upperclass student majoring in entomology or biology.

Kristen R. Hanggi Memorial Nursing Scholarship

Endowed scholarship established in memory of nursing student Kristen Hanggi, Class of 1983 (posthumous), by her parents and friends following her death in 1982, and awarded annually to a senior student majoring in nursing, as recommended by the department faculty.

Anna Paulina Hanson Scholarship

Established in 1921 in memory of 1914 graduate Anna Hanson by her father, the Rev. Petrus O. Hanson of Poplar, Wis., and awarded to a student intending to serve the Lutheran church as an organist.

Brent and Catherine Harms Scholarship

Endowment established in 2003 with a pledge by Brent ’82 and Catherine (Villars ’85) Harms, with preference given to students focusing on business or music.

Oluf and Margaret Haugsrud Scholarship

First awarded in 2000, the endowed scholarship is one of seven established at colleges and universities in Minnesota and Wisconsin by Oluf Haugsrud. Scholarship funds are designated for qualifying students from northern Minnesota (primarily in the counties of St. Louis, Carlton, Lake, Cook, Beltrami, and Koochiching) and northern Wisconsin.

Delphine L. Hedtke Scholarship

Endowed scholarship established in 1998 with a gift by Dr. Delphine L. Hedtke ’53 to assist and encourage students to pursue a degree in education at Gustavus Adolphus College and for whom financial aid is essential. To reflect her long career in teaching and understanding of the importance of education in our society, priority is given to junior and senior students enrolling in the teacher education program for secondary or post-secondary teaching.

Ruth Tolman Helland and Philip C. Helland Scholarship

Endowed scholarship established in 2011 with a cash gift from Ruth Tolman Helland ’49 and her husband, Philip, in memory of their daughter Mary, who tragically drowned in 1975 at the age of 17, “to help other girls achieve a college degree.” The scholarships are to be awarded to women intending to major in the natural sciences (biology, chemistry, physics, geology) or mathematics.

Alfred Henderson Family Scholarship

Endowed scholarship established in 1999 through a gift from Alfred Henderson ’62, and first awarded in 2002–03 to young men and women from Moose Lake and Willow River high schools who have achieved scholastically. It is to be awarded on the basis of academic merit and without regard for financial need, and may be renewed annually for four years as long as the student remains in good standing with the College.

Helmer Hermanson Scholarship

Endowed scholarship established in 1965 through a bequest from Helmer Hermanson, a friend of the College from Nicollet, Minn.

HickoryTech Corporation Foundation Scholarship

Endowed scholarship awarded to students from Nicollet, Blue Earth, or Waseca counties who are in their junior year; it may subsequently be renewed for the senior year. HickoryTech is a diversified communications company headquartered in Mankato, Minn., with operations in Minnesota and Iowa. The company was established in 1898 with its roots in the local telephone exchange business. From this base, it has expanded into wireless communications, competitive local service, long distance, Internet, information solutions, and enterprise solutions.

Hoefer-Newkom Scholarship

Endowed scholarships established in 1973 in memory of Leo Hoefer and Louise Hoefer Newkom of St. Peter and awarded annually to St. Peter High School graduates.

Clifford A. and Marjorie I. Hoekstra Family Scholarship

Endowment established in 1997 by Clifford Hoekstra, Gustavus parent and grandparent, in memory of his wife, Marjorie, and to honor the Hoekstra family and their many Gustavus connections.

Hogberg Family Music Scholarship

Endowed scholarship established in 2007 with pledged estate and related assets, wills, and bequests by Stephen Hogberg '69 and his wife, Elizabeth, in honor of their daughters—Karin Hogberg Schatte '98 and Ann Hogberg Johnson, a member of the Gustavus advancement office since 2001—who were both involved in music and musical theater since their high school years and continue to enjoy music today. Active for 2009–10, the scholarship is awarded according to the criteria and processes of the Jussi Björling Music Scholarships.

William E. Holcomb Scholarship

Endowed scholarship established in 1998 through a bequest by William E. Holcomb, after visits with Lucille Westerdahl Hope '41, the widow of William's brother, Dr. John Holcomb '39. It is intended for science and pre-medicine students wishing to pursue an education at Gustavus.

Judge Andrew Holt Scholarship

Endowed scholarship established in 1983 in honor of the judge, who attended St. Ansgar's Academy in the 1860s, by the congregation of St. John's Lutheran Church of Minneapolis.

Honoring Faculty 1918–1922 Scholarship

Endowed scholarships from a fund established by the Class of 1922 to honor their professors.

Bernard and Louise Hoogenboom Scholarship

Endowed scholarship established in 2011 with a cash gift from longtime chemistry professor Bernard Hoogenboom (taught 1958–1996) and his wife, Louise, "in gratitude to the College for the many opportunities . . . to do research, travel, and work with students to instill in them the fascination of chemistry that has filled his life." The scholarship is designated for a junior or senior student majoring in chemistry and who is a non-Minnesota resident.

Clifford and Edith Hoy Scholarship

Endowed scholarship selected by Gustavus and established in 1979 by Clifford Hoy '34 and his wife, Edith (Danielson '35) Hoy.

Harold A. and Bonnie M. Hunt Scholarship

Endowed scholarship established in 2001 by Harry and Bonnie Hunt, friends of the College from St. Peter, Minn., whose son, Chad, graduated from Gustavus in 1994; it has been active since 2006–07, with preference given to students from the greater St. Peter area.

Orville and Marymar Iverson Scholarship

Endowed scholarship established in 2005 with a gift from Orv Iverson, a World War II veteran who graduated with the Class of 1950, and his wife, Marymar. The Iversons both found great satisfaction in elementary school teaching, and their scholarship is awarded with preference given to students who are majoring in elementary education.

The Reverend Dr. Andrew Jackson Memorial Scholarship

Endowed scholarship established by the Minnesota Conference of the Augustana Lutheran Church to honor the Rev. Andrew Jackson, an early president of the College (1863–1873 and 1874–1976); it is awarded to students intending to enter the ELCA ministry.

Harold and Madeline Jacobs Scholarship

Established in 1981 and endowed in 1996 by Madeline Jacobs, a friend of the College, for the benefit of women science students.

Gladys P. and Henry L. Jacobson Scholarship

Endowed scholarship established in 1987 by Henry L. Jacobson '27 and his wife, Gladys, to help meet the objectives of the 125th anniversary campaign. Mr. Jacobson had a long career with the United States Weather Bureau and was the first member of the Bureau to hold the title of chief forecaster. Preference is given to students from rural areas.

JEM Technical Scholarship

Endowed scholarship established in 2012 by John E. Menge '66 and his wife, Sheryl Anderson Menge '67, and their daughter, Andrea Menge Tysdal '98, with a cash gift to the College. The scholarship is named for the manufacturing and distribution company—JEM Technical—that John founded in 1984 and for which Andrea now is vice president, and aims to "enable more Gusties to propel themselves into a successful career and a lifelong path of learning." Preference is to be given to students studying economics and management.

Nichole Stavros Jenny Scholarship

An annual scholarship established in 2010 with a gift from Jason Jenny in memory of his late wife, Nichole Stavros Jenny '92, a dedicated member of the nursing staff at Hennepin County Medical Center's surgical unit and the allergy and asthma staff at Southdale Pediatrics in Edina for many years. Honoring Nichole's experiences with the varsity women's soccer team and with her sorority, the scholarship is designated for students involved in co-curricular activities, thus serving as a lasting legacy to Nichole's passion for life and her dedication to an active lifestyle.

Chester Johanson Scholarship

Endowment established in 1981 by Chester Johanson, friend of Gustavus Adolphus College, to support pre-medicine and/or health science students.

Addie A. Johnson Scholarship

Endowed scholarship established in 1994 by Addie Johnson through a gift annuity, with preference indicated for students from St. Peter and the surrounding area.

Anna C. Johnson Scholarship

Endowed scholarship named for 1908 graduate and former College registrar Anna Johnson (served 1928–1941).

The Rev. Bernhard and Evelyn Nordstrom Johnson Scholarship

Current scholarship established in 2013 in memory of the Rev. Bernhard '39 and Evelyn Nordstrom '40 Johnson by their daughter, Siri Johnson Quitmeyer, and her husband, John Quitmeyer, with a cash gift. A tribute to the Johnsons' ministry and service to the Lutheran Church, it is designated for third- and fourth-year students planning to enter the Lutheran ministry.

Dora Rhodes Johnson Scholarship

Endowed scholarship established through the will of Dora Rhodes Johnson, a friend of the College, in 1978.

Dr. Eddie W. and Dr. Ruth Erickson Johnson Scholarship

Endowment initially funded in 2000 by a bequest from the estate of Eddie Johnson '39, who was the first director of admissions at Gustavus and later a renowned audiologist, and his wife, Ruth (Erickson '41) Johnson, a clinical psychologist, together with memorial gifts from family and friends; completed in 2003 with gifts by their daughter, Karen Ganulin and her husband, Rick, and first awarded for the 2003–04 school year. The scholarship honors the spirit of the couple, both of whom were recognized by the College with Distinguished Alumni Citations for exceptional professional achievement—Eddie in 1965 and Ruth in 1989.

Edith M. and Arnold H. Johnson Scholarship

Endowed scholarship given by the parents of Eunice A. Anderson '48, Lloyd W. Johnson '58, and Orville D. Johnson '59, as a means of encouraging students who have need for financial assistance in order to attend the College. The Johnsons' deep roots in the Minnesota Conference of the Augustana Lutheran Church, the Swedish Lutheran founding body of the College, instilled in them a strong faith in education and stewardship at Gustavus.

Hazel M. Johnson Scholarship

Endowed scholarship established in 1990 in consideration of assignment of a Lutheran Brotherhood life insurance policy from the estate of Hazel Johnson, emerita professor of nursing at the College (taught 1969–1981), who died in 2010. First awarded for the 2010–11 school year, it is designated to provide encouragement to “young men and women from Third World countries” who desire a Gustavus education.

John W. and Marion Myrland Johnson Scholarship

Endowed scholarship established in 2005 with a gift from John Johnson, a Minneapolis native who served on the Minneapolis City Council and in the Minnesota Legislature, and his wife, Marion Myrland Johnson, who attended the Gustavus for one year in 1947–48. It was first awarded for the 2006–07 school year.

Kaufmanis Mathematics Award

Endowed scholarship established by Nu Upsilon Gamma fraternity in honor of mathematics professor Karlis Kaufmanis (taught 1949–1963) and awarded in the junior year to mathematics majors who demonstrate need and have shown outstanding scholarship in mathematics, as recommended by the mathematics/computer science faculty.

Linda Bailey Keefe and Fleming Keefe Scholarship

Endowed scholarship established in 2000 by Linda Bailey Keefe '69 and her husband, Fleming, and designated for “at least one male and one female student who have shown in their lives a true love of music, demonstrated a commitment to the study of voice, are members of the Gustavus Choir, and for whom financial aid is essential in order to permit their attending Gustavus Adolphus College.”

Gerda and Leonard Kendall Scholarship

Endowed scholarship established by the Luther League of the Minnesota Conference of the Augustana Church at the time of its merger into the LCA in 1962, and honoring Leonard Kendall, the last president of the Minnesota Conference (served 1955–1962) and father of the late John S. Kendall '49, 12th president of the College; it was augmented in 1985 by memorial gifts for Leonard's wife, Gerda.

Albert and Gladys Kiewatt Scholarship

Established in 2003 with the charitable remainder from an annuity given to the College in 1995 by the Kiewatts, friends of the College, with preference given to students from LeCenter, Minn., and the surrounding area.

Mary Lee Anderson Knips Scholarship

Endowed scholarship established initially by family and friends of Mary Lee Anderson Knips '52, following her death in 1959, and augmented with a major gift from the estate of Carl I. Salstrom in 1989.

F. Edwin Knock Scholarship

Endowed scholarship selected by Gustavus and named for 1912 graduate Edwin Knock.

H. Clifton Kroon Debate Scholarship

Endowed scholarship established in 1995 by H. Clifton Kroon '44 to provide scholarship assistance to students who are participating in the debate program at the College.

Anna Pitzel Krost and J. Fred Krost Charitable Trust Scholarship

Perpetually sustained scholarship from a trust established by J. Fred Krost in 1976; it was first awarded for the 1984–85 school year.

Pamela Ranae Ehde Lais Scholarship

Endowed scholarship established in 1997 by Art and Carol Ehde in memory of their daughter, Pamela Ehde Lais '94, who died in 1996; it is designated for computer science majors.

Dorothy Sjoquist Lammers Memorial Scholarship

Memorial to Dorothy Sjoquist Lammers to provide scholarship funding for a string music student. Dorothy Lammers was a member of the Gustavus orchestra whose husband, Mark, is Research Professor in Music at the College.

Anna K. Sorensen Larsen and the Rev. Bertel S. Larsen Scholarship

Endowed scholarship established in 1983 through the will of classics professor Bertel Larsen (taught 1955–1972) and also honoring his mother; it is awarded annually to a pre-theology student.

B. Jeanette Larson Scholarship

Endowed scholarship established in 1996 by B. Jeanette Larson's daughter, Linda Larson McNary '65, other family members, and many friends to honor “Jean,” Class of 1954, on the occasion of her 80th birthday. The scholarship recognizes Jean's distinguished career as manager of the Gustavus Book Mark (1948–1983) and her devotion to Gustavus students over several decades.

Elaine Maurice Larson Scholarship

Endowment established by family as a memorial to Elaine Maurice Larson '44, it was designed to provide scholarship funding to encourage students who are preparing for careers in the fields of music and art or who may have an interest in Reformation history.

Oscar and Mildred Larson Scholarship

Endowed scholarships established at three colleges in 1981 through the will of the Larsons “to promote goodwill and friendship between the peoples of the United States and the Kingdom of Sweden”; it is designated for students of Swedish descent. A portion of the fund is awarded to students from Sweden to assist them during their time at Gustavus.

Richard A. Larson Designated Endowed Scholarship

Established in 2005 by a bequest from Richard A. Larson of rural St. James, Minn., who had many family members who attended Gustavus. Larson, who was “very proud of his Swedish background, loved his church, and loved the idea of Gustavus with its Swedish and Lutheran background,” intended that the scholarship be awarded to “students who have financial need and who are from Watonwan County, Minnesota.” It was first awarded for the 2006–07 school year.

Richard A. Larson Undesignated Endowed Scholarship

Established in 2005 by the remainder of a gift annuity from Richard A. Larson, St. James, Minn. (see above), who, although he did not himself attend Gustavus, had several family members who did and “always thought very fondly” of the College. It was first awarded for the 2006–07 school year.

Lawson Family Scholarship

Endowed scholarship established in 2007 by the family of Roderick and Helen Lawson, friends of the College, using the proceeds from a charitable remainder unitrust. The scholarship is to be awarded to students with financial need.

Selma Lee Nobel Science Scholarship

Endowed scholarship established in 1965 by the will of Selma A. Lee of Minneapolis, a Swedish immigrant who had learned about the school’s just-completed Nobel Memorial Hall of Science through a Gustavus alumnus. This scholarship endowment was augmented in 1996 by a bequest provision of Kenneth H. Lee, Selma Lee’s son, who specified that his gift should be added to the fund that his mother had established at Gustavus Adolphus College. The scholarship is designated for students in the sciences.

Myrtle Holteen Lekvold String Music Scholarship

Endowed scholarship established in 1992 by Myrtle Holteen Lekvold ’32, and first awarded in 2000 to “provide encouragement to students who desire a Gustavus education and who will be participating in the string music program.”

LeVander Family Scholarship

Endowment established in 1995 by Bernhard W. LeVander ’37 as a fund through which LeVander family members might express their affection for Gustavus Adolphus College, and to provide scholarship aid to students, with preference to students who include speech activities as part of their collegiate experience at Gustavus. This scholarship pays lasting tribute to the LeVander family, including Bernhard’s two brothers, Theodor ’31 and Harold ’32 (Governor of Minnesota, 1967–1971).

Margot C. and Harry Levy Scholarship

Endowed scholarship established in 1997 by the children and grandchildren of Margot Levy to honor their mother and grandmother. Levy is the mother of former Gustavus president Axel Steuer (served 1991–2002).

Carl and Betty Lind Scholarship

Endowed scholarship established by Dean Emerita Melva Lind (taught 1953–1973) in memory of her parents, with preference given to students in music, French, or pre-medicine.

Colonel Carl John Lind, M.D., Memorial Scholarship

Endowed scholarship established in 1995 by Professor of French and Dean Melva Lind (taught 1953–1973) to honor the memory of her brother, Colonel Carl John Lind, M.D., whose distinguished medical career included positions as senior pathologist at Walter Reed Army Hospital, Washington, D.C., and chief of laboratory services at St. Luke’s Hospital, Houston, Texas. The scholarship recognizes the scholarly work of junior- or senior-level students who intend to pursue careers in the health professions.

Lindborg-Jonaitis Scholarship

Endowed scholarship established in 1998 in the name of Charles Jonaitis and Karen Lindborg Jonaitis ’63, it is intended to provide tuition funds to English majors.

Roy and Irene Lindenberg Scholarship

Endowed scholarship established by Richard Crawford Sr. and named in honor of 1925 graduate and longtime Gustavus coach Roy “Tuddie” Lindenberg and his wife, Irene (Haugdahl ’27) Lindenberg; it is awarded annually to a St. Peter High School graduate who participated in athletics, reflecting Tuddie’s service as a teacher and coach for St. Peter High School.

Edward T. Lindsten Scholarship

Endowed scholarship selected by Gustavus and named for 1926 graduate Edward Lindsten.

Jeanne and Ernie Lindstrom Scholarship

Established as an annually sustained scholarship in 2003 for a 10-year period by Jeanne Turnquist Lindstrom ’59 and her husband, Ernie, and endowed in 2012 with an outright gift from the Lindstroms. The scholarship is designated for students who are majoring in elementary education.

Sandra Bottge Lipke Scholarship

Endowed scholarship established in 1998 in memory of Sandra ’64, by her husband, John W. Lipke ’63, and their children and spouses: J. Eric Lipke ’89; David S. Lipke ’91 and Stacy Lipke; Kirsten M. Lipke ’93; and Kari A. Lipke ’98. It is designated to provide financial assistance to men and women choosing Gustavus Adolphus College.

John O. and Grace I. Luhmann Scholarship

Endowed scholarship established in 1991 by Kurt Luhmann ’63 and Gracia Luhmann Hegener ’66, the son and daughter of John O. and Grace I. Luhmann; it is designated for hearing-impaired students.

The Reverend Doctor C. Albert and Bertha Elizabeth Lund Scholarship

Endowed scholarship established in 2008 by a bequest from the late Wendell and Marian Lund in memory of Wendell’s parents, the Rev. Dr. C. Albert Lund, Class of 1899, and Bertha Elizabeth Lund, and his close friend, Lloyd O. Swanson ’35; it was first awarded for 2009–10.

Patricia Lund Scholarship

Endowed scholarship established in 1994 by Patricia Lund, a great friend of the College, and first awarded for 2010–11.

Roy M. Lund and Joyce Lund Froehlig Scholarship

Endowed scholarship established in 1982 in memory of the Rev. Roy Lund '54. This scholarship was renamed in 1998 through a bequest from Lund's widow, Joyce (Lindell '54) Froehlig.

William O. and Natalie C. Lund Scholarship

Endowed scholarship established in 1998 by Natalie C. Lund, a longtime benefactor of Gustavus, to honor the memory of her husband, William O., a trustee of the Greater Gustavus Fund who always believed in helping people receive the education they needed to perform up to their abilities. It is to be given to students needing financial assistance, with priority given to those who intend to major in communication studies or a related field.

Dr. Richard Lundborg and JoAnn Johnson Lundborg Scholarship

Endowed scholarship established in 2001 by 1955 graduate Richard '55 and JoAnn (Johnson '56) Lundborg, and first awarded in 2003 to junior or senior students in pre-medicine curricula or pursuing a degree in education. The Lundborgs have been devoted to education, to medicine, and to volunteer efforts to make a difference in the lives of students and patients.

Ruth and Paul Lundgren Scholarship

Endowed scholarship established through the will of 1917 graduate Paul Lundgren, a district judge and chief judge of the Ninth Judicial District, and by his wife, Ruth (Nelson '17). A major gift from the estate of the Lundgrens enabled the scholarship to be awarded starting with the 1985–86 school year.

Dr. Arthur M. and Agnes T. Lundholm Scholarship

Unrestricted scholarship endowment established in 1994 with gifts from the estates of Dr. Arthur M. and Agnes T. Lundholm, friends of the College from Braham, Minn. Dr. Lundholm's career included many years of service as a physician at Bethesda Lutheran Hospital in St. Paul, Minn.

Axel F. and Mary Lundquist Memorial Scholarship

Endowed scholarship established in 1970 through the will of Mary Lundquist, mother of Ebba Lundquist Berquist '38. It is restricted to students preparing for the ministry.

Lutheran Brotherhood Endowed Scholarship

Provided through an endowment established by Lutheran Brotherhood; awarded beginning in 1984 to Lutheran students as selected by the College. Lutheran Brotherhood merged with Aid Association for Lutherans in 2002 to become Thrivent Financial for Lutherans.

Alfhild M. and Carl F. Maedl International Scholarships

Established in 1999 as part of a significant gift from Alfhild Peterson Maedl '35 and her husband, Carl (see also below and the awards listed on p. 9), the Maedl International Scholarships endowment annually provides four four-year merit awards to outstanding international students wishing to study at Gustavus—with the intention being that one each come from the Far East, Central America, Germany, and Sweden.

Maedl-Peterson Family Scholarship

Endowed scholarship established in 2001 by Alfhild Peterson Maedl '35 and her husband, Carl, to honor Alfhild's parents, Conrad Peterson (taught 1908–1956) and Eda Anderson Peterson, and also the Maedl family, including daughters Patricia Maedl Krough '61, and Pamela Maedl Gutowski '71, and grandson Todd Krough '85. The Maedls established this and other endowed scholarships at the College "in appreciation to those who made gifts to help us grow" and to "make a difference for students for years to come." The Maedl-Peterson Family Scholarship was first awarded in 2003.

George and Mary Ellen Malkasian Family Scholarship

Endowed scholarship established in 2000 by the Malkasians, whose daughter, Martha, is a 1983 graduate of the College. Preference is given to pre-med students or music students, reflecting George's career as a physician at Mayo Medical Center in Rochester and Mary Ellen's as a music teacher.

Mansergh Award

Endowed awards established in 2007 as the Gordon Mansergh Scholarship with gifts from Mansurgh, a 1984 psychology graduate who was the founding director of the Wellness Center at Boston University and since 1995 has worked with the U.S. Centers of Disease Control and Prevention (CDC), most recently as senior behavioral scientist in the Division of HIV/AIDS Prevention. Renamed the Mansergh Awards in 2011 and active at that time, the awards facilitate credited experiences of junior or senior Gustavus students involved in internships (January IEX internships and otherwise) in U.S. federal agencies that address public health issues. The Provost's Office shall oversee the selection of each year's Mansergh Award recipients, with input from appropriate academic departments and faculty.

Hiram Edward Manville Foundation Scholarship

Endowed scholarships given by the foundation established through the will of H. Edward Manville, father of Estelle Bernadotte (widow of U.N. mediator Folke Bernadotte, for whom the Gustavus library is named), to the College's Folke Bernadotte Memorial Foundation in 1952. It is to be used "for the study and improvement of human and international relations" with preference given to political science majors.

Joanne McCarthy Scholarship

Endowed scholarship established in 1986 by Joanne (Nelson '58) and Charles McCarthy to provide scholarship assistance to students from rural Minnesota.

Medtronic Foundation Scholarship

Awarded to Minnesota students who are traditionally under-represented in the sciences. This scholarship is distributed through the Minnesota Private College Fund. Medtronic is the world's leading medical technology company, providing therapies for treating diseases of the heart's electrical conduction system, for use in cardiac surgery and other invasive procedures, and for treating pain and controlling movement disorders.

Meslow First Generation Scholarship

First awarded in the 2005–06 academic year by the Meslow Foundation through the Minnesota Private College Fund, and intended to “help launch the academic careers of promising new first-generation college students from families with incomes under \$50,000.” The scholarship is awarded to one eligible first-year student from each of the 17 Minnesota private colleges and universities and may be renewed for the sophomore year, contingent upon academic standing and participation on campus and in the community.

Roy and Merle Meyer Scholarship

Endowed scholarship established in 1984 by the Meyers, founders of Meyer Industries of Red Wing, Minn.

John S. and Una E. Milton Scholarship

Endowed scholarship established in 1985 by memorial gifts from Una Milton, mother of former First Lady Joanne Milton Kendall; this scholarship was awarded for the first time in 1986–87.

Minnesota and Red River Valley Synods of the Lutheran Church in America Leadership for Tomorrow Scholarship

Established in April 1986 with gifts from congregations in the Minnesota and Red River Valley Synods of the Lutheran Church in America (LCA) to Gustavus Adolphus College. The fund was set up as a parting endowment to the College from the Minnesota and Red River Valley Synods prior to the merger of the LCA into the Evangelical Lutheran Church in America (ELCA).

Minnesota Mining and Manufacturing (3M) Liberal Arts Scholarships

Scholarship endowment funded by 3M to recognize the College’s “consistent demonstration of its commitment to liberal arts education through excellent course offerings by highly respected professors”; preference is given to United States citizens.

Minnesota Mutual Foundation Scholarship

Minnesota Mutual scholarships are awarded through the Minnesota Private College Fund to students majoring in business, economics, or mathematics. Minnesota Mutual provides insurance and investment services to individuals and businesses.

Minnesota Power Scholarship

Minnesota Power owns and operates utilities and utility-related companies in six states, providing electric service to northern Minnesota and northwestern Wisconsin. The Minnesota Power Scholars program provides financial aid through the Minnesota Private College Fund for students from the company’s Minnesota service area.

Minnesota Scholars Scholarship

Awarded to students from Minnesota through the Minnesota Private College Fund.

Nels N. (Moberg) Molbert and Ida E. (Persson) Molbert Scholarship

Endowed scholarship established by Ralph N. Molbert of Steele, N.D., in 1985 to honor the memory of his mother, Ida, and father, Nels (who attended Gustavus in 1881–82), and designated for students from the Dakotas who are of Swedish descent.

Kay and Robert Moline Nursing Scholarship

Endowed scholarship established in 2008 by two longtime faculty members at the College, Kay Rethwill Moline ’56 (taught nursing 1970–2000), and her husband, Bob (taught geography 1961–1998), with preference given to nursing majors with financial need who have achieved GPAs of at least 3.33 and who are children of Gustavus nursing alumni; it was first awarded for 2009–10.

Robert and Kay Moline Environmental Studies Scholarship

Endowed scholarship established in 2006 with a gift from emeriti professors Bob Moline (taught geography 1961–1998) and Kay Rethwill Moline ’56 (taught nursing 1970–2000) and awarded “to encourage students to develop a love for the environment, pay attention to it, solve problems, and lift up good stories.” Preference is given to a senior environmental studies major who demonstrates genuine interest in the field as shown by a record of campus activities relating to environmental issues and off-campus work on behalf of the environment.

Brian Moody Memorial Scholarship

Endowed scholarship established in 2002 by Richard and Beverly Moody to perpetuate the memory of their son, Brian Moody ’88, who died in 2000 while piloting an airplane chartered to survey the mule deer population along the Snake River in the mountains of Oregon and Idaho. Preference is given to students with a major or minor in geography, or to students needing assistance with the costs of studying abroad; the donors consider it important that scholarship recipients “know that Brian was an extraordinary person pursuing his passion for flying in the great outdoors that he loved so much.”

Helen Muskat Scholarship

Endowed scholarship established in 1998 by Helen Muskat, a friend of the College and the cousin of Carl F. Nelson ’51. Carl introduced Helen, who was originally from Mankato, to Gustavus, and Carl and his wife, Leslie, kept Helen in touch with the College.

Naplin Family Scholarship

Established in 2004 with a gift from June Naplin Christensen ’46 and her husband, Raymond, in honor of her parents, Carl and Clara Naplin. Additional gifts were given by Arloine Naplin Webber, June’s cousin, in honor of Arloine’s father, Oscar Naplin, a 1905 graduate of Gustavus. The Naplin family recognized the importance of higher education, and June’s parents sent three children—Edgar ’34, Alvin ’37, and her—to Gustavus. The scholarship, first awarded for the 2005–06 academic year, is designated for students from rural areas.

A. Hamilton and Natalie C. Nelson Scholarship

Established in 2001 with an initial gift of the remainder of the 10-year term of an annuity trust set up in 1992 by A. Hamilton Nelson and his wife, Natalie, in honor of his grandfather, Andrew Nelson, the first treasurer of Gustavus Adolphus College and one of the men responsible for bringing the Swedish school formerly located in East Union, Minn., to St. Peter in 1876; it was first awarded for 2003–04.

Andrew Nelson International Student Scholarship

Endowed scholarship established in 1996 by Marianne Colberg Keswani '52 and other descendants and friends, as a memorial to her great-grandfather Andrew Nelson, a Swedish immigrant farmer who became the first treasurer of St. Ansgar's Academy and was later instrumental in securing funds to bring that school to St. Peter as Gustavus Adolphus College. Reflecting Marianne's own 16-year service as foreign student coordinator for the Office of International Education at the College, the scholarship is designated for international students who desire a liberal arts education at Gustavus.

Pastor Carl O. and Edith Nelson Scholarship

Endowed scholarship established in 1998 by their son, the Rev. Carl O. Nelson Jr., to honor the elder Pastor Nelson, who served in Lutheran churches in Iowa and Minnesota, and his wife. The scholarship provides assistance to students preparing for ordained ministry in the Lutheran church.

Clifford Ansgar and E. Bernice Nelson Scholarship

Endowment established in 1995 by family members and friends to honor the lives and achievements of the Rev. Dr. Clifford Ansgar Nelson, a member of the College's board of trustees from 1951 to 1954, and his wife, Bernice (Nelson '33), and to celebrate the Nelson family ties to Gustavus. All three of their sons—Clement '57, Rolf '62, and Brent '65—also attended Gustavus.

Doris Mae and Nels K. Nelson Scholarship in Religion

Endowed scholarship established in 1996 by Doris Mae and Nels K. Nelson, parents of Marilisa Anne Nelson '90, to provide financial assistance to students enrolled in a pre-seminary curriculum or who are majoring in religion.

Dr. Frank Nelson/Minnesota College Scholarship

Endowed scholarship established in 1968 and selected by the Alumni Association of Minnesota College; it is designated for descendants of Minnesota College graduates, with preference given to those preparing for a church vocation.

Kenneth and Ila Nelson, Mildred L. Nelson and Harold and K. Lorette Lackey Scholarship

Endowed scholarship established in 1991 by K. Lorette Lackey, daughter of Axel Nelson, Class of 1899, and Mary Nelson, to honor her family.

Marilisa Anne Nelson Memorial Scholarship

Endowment established in 1992 by friends and family in memory of Marilisa Anne Nelson '90, to provide financial assistance to Chinese students desiring to attend Gustavus Adolphus College.

Nels K. Nelson and Doris Mae Nelson Scholarship

Endowed scholarship established in 1993 by Nels K. and Doris Mae Nelson, parents of Marilisa Anne Nelson '90, to encourage students whose majors are Greek, classics, and/or art history.

Dr. and Mrs. H.J. Nilson Scholarship

Endowed scholarship established by Ronald '56 and Janet (Elwood '57) Nilson, of Vancouver, Wash., in memory of his parents.

Edwin and Edith Byquist Norberg Scholarship

Endowed scholarship established in 1980 by Edwin Norberg in memory of his wife, a noted Twin Cities musician who was the former choir director at Mount Olivet Lutheran Church, and now honoring Edwin's memory as well; it is presented annually to an upperclass church music major.

Hartley and Ruth Nordin Scholarship

Endowed scholarship established in 2007 with the remainder of several charitable gift annuities given to the College between 1999 and 2007 by Hartley Nordin '44 and completed by his wife, Ruth. Hartley, who died in 2004, had a distinguished career with the offices of the state attorney general, the U.S. district attorney, and the Minneapolis federal bankruptcy court.

W. Stanley and Coral Carter Nordstrom Family Scholarship

Endowed scholarship established in 2001 by Coral Carter Nordstrom, who attended Gustavus for two years and whose husband, W. Stanley, was a 1938 graduate of the College. Coral's mother, Augusta Johnson Carter, was a 1913 graduate, and two of Stanley and Coral's three children—Lyna Lou '68 and James '70—also attended. Preference is given to junior or senior students involved in the music department, particularly in vocal music.

Grevilda C. Norman Scholarship

Endowed scholarship established in 1984 through the will of Grevilda Norman, a secondary school teacher from Milaca, Minn.

Marvin T. Nystrom Scholarship

Endowed scholarship established as a permanent expression of the longtime interest of Marvin T. Nystrom in Gustavus Adolphus College; it is available to junior or senior students in good academic standing.

Linda Stone O'Brian Nursing Scholarship

Endowed scholarship established in 1990 by Patrick O'Brian, the husband of Gustavus graduate Linda Stone O'Brian '68, and friends to provide financial assistance to students in the nursing or health-related programs at Gustavus.

Emma C. Olson Scholarship

Endowed scholarship established through the will of Emma Olson of Stillwater in 1957; it is awarded to a student preparing for the Lutheran ministry.

F. Milo and Carole Paulson Olson Scholarship

Endowed scholarship established in 1996 by Carole Paulson Olson '61 and her husband, F. Milo Olson, parents of Erik '90 and Johanna '94, to provide scholarships to students desiring to attend Gustavus Adolphus College.

Mabel Olson Scholarship

Unrestricted endowed scholarship assigned by the College.

Barbro and Bernard Osher Scholarship

Endowment established in 1999 through grants from the Bernard Osher Jewish Philanthropies Foundation and the Barbro Osher Pro Suecia Foundation, both of San Francisco, to support Swedish students studying at Gustavus and Gustavus students either studying in Sweden or with Swedish-American heritage.

Maria Jimena Rios Owens Scholarship

Endowed scholarship established in 1986 by family and friends in memory of Maria Jimena Rios Owens '86, from Bolivia, South America, to provide financial aid for students from Bolivia or another Latin or Central American country or an international student from a developing country.

Page Education Foundation Scholars

Established in 1988 by the Hon. Alan Page, associate justice of the Minnesota Supreme Court, to provide educational opportunities for students of all backgrounds, and awarded through statewide competition. The Page Education Foundation stipulates that the scholars perform volunteer service in their home communities assisting elementary and/or middle-school students.

Sara Palmer Memorial Scholarship

Endowed scholarship established in 2000 by James and Deborah Palmer in memory of their daughter, Sara, a member of the Class of 2000 who was tragically killed in an automobile accident in November of 1999. Preference is given to junior and senior students who are majoring in English.

George E. and Mary Jane Patchin Scholarship

Endowed scholarship funded in 2002 by George and Mary Jane Patchin of Mankato, Minn., friends of the College and parents of 1995 graduate Jane Patchin Lalim, with the remainder of a gift annuity established with the College in 1994, and first awarded in 2003. Preference is given to students majoring in elementary education and/or students with a documented disability.

Aaron and Geoline Pearson Family Music Scholarship

Funded in 2005 as an annually sustained scholarship and reestablished as an endowed fund in 2010 by Valborg Pearson in memory of her parents and five siblings, who were lifelong residents of the St. Peter/Scandian Grove area. Her father, Aaron Pearson, taught violin in the School of Music and led the Gustavus orchestra (1905–1907); her mother, Geoline Dahl Pearson, attended the School of Music; and her sister Ruth toured with the Gustavus choirs as guest violinist. As all of her family prized music and were accomplished musicians, the scholarship has been designated for students studying piano and/or strings.

Delores L. and Sven Martin Pederson Scholarship

Endowed scholarship established in 2007 by Delores Gardner Pederson '48 with the remainder of charitable gift annuities given to the College by her and her late husband, Sven Martin Pederson, between 1999 and 2007. Recognizing Delores's career of more than 30 years in public health and mental health nursing and Martin's lifetime occupation as a dairy and cattle farmer, the scholarship is designated for students going into either the medical field or agriculture. It was first active in 2010–11.

Ethel M. Pehrson Applied Music Scholarship

Established in 1989 through trust agreements between the College and Ethel Pehrson '30 dating 1978–1988, and active since 2007–08; it is intended to provide scholarship assistance to "students of piano, thereby encouraging potentially gifted students to pursue the serious study of music," and to "players of instruments for orchestra." Academic achievement of applicants is to be considered as well as musical abilities, "recognizing the correlation that often exists between talent and intelligence."

James C. and Joan Pengra Scholarship

Endowed scholarship established in 2007 with a gift from James Pengra '46, who had attended the College through the U.S. Navy's V12-5 officer candidate school, and his wife, Joan. The couple has been involved with the Gustavus V12-5 advisory board, planning reunions and other projects on behalf of the nearly 1,600 men who attended Gustavus from 1943 through 1945 in the V12-5 program.

Angelo F. and Blanche A. Pergol Scholarship

Established in 2001 by Blanche Isenberg Pergol '41, in memory of her husband, Angelo '41. Angelo, an outstanding basketball player for the Gusties, went on to teach and coach at several Minnesota high schools, ultimately becoming athletics director at St. Cloud Apollo High School; he encouraged many students to go on to college and to excel in athletics. The scholarship, first awarded for the 2006–07 school year, is intended for "students for whom financial aid is essential in order to permit them to attend Gustavus and who reflect Angelo's special interest in athletics."

Lee and Virginia Petersen Scholarship

Endowed scholarship established in 2012 with a significant gift from Ginny Hendrickson Petersen '67 and her husband, Lee Petersen '68, of Spring, Texas. Lee, a biology and geology major, earned advanced degrees and has had a distinguished career as a petroleum geologist; Ginny majored in biology and, after interning in medical technology during her senior year, was a longtime medical technologist. In addition to establishing this scholarship, the couple simultaneously funded two other endowments: a scholarship in honor of emeritus geography professor Robert Moline (taught 1961–1998; see below), and a fund in honor of emeritus geology professor Keith "Joe" Carlson (taught 1966–2002—Lee was one of his first students) to support student and faculty research, student activities, field trips, etc. in the Department of Geology.

Lee and Virginia Petersen Scholarship in Honor of Robert Moline

Endowed scholarship honoring emeritus geography professor Robert Moline (taught 1961–1998), established in 2012 with a gift from Ginny Hendrickson Petersen '67 and her husband, Lee Petersen '68, of Spring, Texas. In addition to establishing this scholarship, the couple simultaneously funded two other endowments: another scholarship (see above), and a fund in honor of emeritus geology professor Keith "Joe" Carlson (taught 1966–2002) to support Geology Department activities.

A.Y. and Lillie Peterson Scholarship

Endowed scholarship established in 1979 through the will of A.Y. Peterson, the former president of Oliver Mining Company in Duluth; recipients are selected by Gustavus, with preference given to "worthy students from the state of Minnesota."

Dr. Conrad A. and Florence M. Peterson Scholarship

Endowed scholarship established in 1994 with gifts from the estate of Conrad A. and Florence M. Peterson to provide scholarship assistance for students majoring in history. Conrad Peterson served on the faculty and later as College archivist from 1908 to 1956; Florence M. Peterson '22 served as College archivist from 1956 to 1988.

Ellery and Aileen Peterson Accounting/Mathematics Scholarship

Endowment established in 1993 by Ellery and Aileen Peterson as a permanent expression of the career of Ellery Peterson, professor in the Department of Economics and Management (taught 1957–1991), and of the faith of the Peterson family (Ellery '49, Aileen, Kristin '75, Craig '77, Carolyn '81, Kathryn '84, and Joel) in church-related higher education, especially as reflected in the program of Gustavus Adolphus College. This scholarship is for students who require financial assistance and who major in accounting, with preference for those who may also have a strong background in mathematics.

Marshall A. Peterson Scholarship

Endowed scholarship established in 2009 with a gift from the late Marshall A. Peterson, a longtime member of The Lutheran Church of the Master in Brooklyn Center, Minn., who previously had assisted a number of young people from his church who attended Gustavus. Following the wishes of Peterson, who had great respect for his sister, Anna, a nurse, the scholarship is designated for a student from the congregation of The Lutheran Church of the Master who is studying nursing at Gustavus or, if there are no nursing students from the congregation in a given year, any nursing student from Ramsey or Hennepin County. The scholarship was first active in 2010–11.

Sister Nellie Rose and Anna Marie Peterson Nurses Scholarship

Endowment established in 1987 by Marshall A. Peterson to honor the memory of his sisters, Nellie R. and Anna M. Peterson. Scholarships are to be awarded to students in hospital training in the Gustavus Adolphus College registered nurse program. The awards were first presented for the 1988–89 academic year.

Linnea Sponberg Peterson Scholarship in Nursing

Endowed scholarship established in 1992 by Raymond Sponberg '37 and his wife, Florence, to honor the memory of Ray's sister, Linnea Sponberg Peterson, a student of Minnesota College and a member of the nursing profession. The scholarship provides financial assistance to nursing majors with preference given to non-traditional students.

Ranae J. and Robert A. Peterson Scholarship

Established in 1999 by Robert Peterson, Class of 1958 and former vice president for development of the College (served 1958–1996), and his wife, Ranae, who taught in the French department, to encourage the learning of foreign languages and international studies; active in 2012–13, it is designated for students engaged in the study of a foreign language and/or study abroad.

Robert A. Peterson Family Scholarship

Annually sustained scholarships established in 2006 by Robert A. Peterson '74, president of The Hawthorn Group of Tulsa, Okla., with a gift given in four annual installments and designated for students "who bring diversity to campus and who are in very high academic standing."

Cornelia M. Pettis Scholarship

Named for the daughter of early settlers at Lake Emily, Minn., and first awarded in 1949 to encourage and maintain the study of music.

Evangeline Peterson Phalin Music Scholarship

Endowed scholarship established in 1996 through the will of Howard Phalin to honor the memory of his wife, Evangeline Peterson Phalin '15. It is designated for students studying music.

Dr. Lawrence Potts Chemistry Scholarship

Endowed scholarship established in 2008 and funded with gifts made in honor of Professor Larry Potts (taught 1972–2008) upon his retirement from Gustavus. The scholarship is to be awarded to students for whom financial aid is essential in order to permit them to attend Gustavus, with preference given to students majoring in chemistry. It was first awarded for 2009–10.

Timothy Powell-Flatt Scholarship

Endowed scholarship established in 2007 with outright gifts from Timothy Powell-Flatt '91 in gratitude for the liberal arts experience he had at Gustavus and the formative value it has had on his life and career in finance and investments. First awarded for 2009–10, the scholarship is designated for student focusing on economics and management or other coursework leading to a career in business, "but who also pursue a wider liberal arts education as evidenced by eligibility for fine arts scholarships such as the Jussi Björling Music Scholarships, Evelyn Anderson Theatre and Dance Scholarships, or Gustavus Art Scholarships."

Effie Quist Scholarship

Endowed scholarship established in 1983 in the name of Effie Holteen Quist, Class of 1904.

Rahr Foundation Scholarship

The Rahr Foundation is the corporate foundation for the Rahr Malting Company, which manufactures barley malt, malt sprouts, and barley by-products. Scholarships are awarded through the Minnesota Private College Fund.

Reader's Digest Foundation Scholarship

Endowed scholarship established in the 1960s by the Foundation to provide financial assistance to worthy and deserving students.

Margaret and Marlin Reishus Scholarship

Endowed scholarship established in 2008 with an initial gift and pledges of additional gifts over a nine-year period by Margaret (Olson '52) Reishus and her husband, Marlin. The scholarship, first active for the 2009–10 year, is awarded according to the criteria and processes of the Jussi Björling Music Scholarships, with preference given to Minnesota students from outside of the Metropolitan Twin Cities area.

John and Anna K. Rhodes Scholarship

Endowed scholarship deriving from two trusts set up by Anna Rhodes of Willmar, Minn., a friend of the College, beginning in 1948, and supplemented by funds from her daughter, Dora Rhodes Johnson; upon Rhodes's death in 1967, the trust became a scholarship fund designated for descendants of the Rhodes family or, in the event that none is enrolled, for students preparing for pre-medicine, medical technology, physical therapy, nursing, or church vocations in the ELCA.

John O. and Agnes H. Roning Scholarship

Endowed scholarship established in 2000 by John O. Roning, who served the College as dean of men, coach, and director of athletics (Gustavus Athletics Hall of Fame inductee, 1982) from 1939 through 1942, and by his wife, Agnes H. Geib Roning, a Carleton College graduate who was a schoolteacher. Preference is given to students who combine their studies with participation in athletics.

Russell J. and Kathryn M. Rosendahl Scholarship

Endowed scholarships established in 1972 in memory of Russell Rosendahl '28 and his wife, Kathryn.

Robert A. Rossi Scholarship

Established in 2003 with a pledge from Robert Rossi, friend of the College, and active beginning in 2009–10, with preference given to students focusing on mathematics.

Paul L. Rucker Scholarship

This endowed scholarship honors the efforts of Paul L. Rucker, guidance counselor at Quitman County High School in Marks, Miss., in encouraging culturally diverse students to pursue a college education. It is funded in part by donations from Gustavus's Black alumni, some of whom chose to attend Gustavus on the advice of Rucker.

G.L. Rudell Scholarship

Endowed scholarship established by Dr. G.L. Rudell of Duluth, Minn., a 1903 graduate; it is designated for "freshmen of high academic achievement in high school."

Douglas Sandberg Scholarship

Endowed scholarship established in 1974 by family and friends in memory of Doug Sandberg '70, admissions counselor at Gustavus Adolphus College (1970–1974).

Joel Alexis Sandberg Memorial Scholarship

Endowed scholarship established by the Rev. Ralph and Eleanor Sandberg in memory of their son, Joel '67, who was the first Gustavus graduate to die in Vietnam; it is awarded annually to an outstanding junior or senior art major, as selected by the department.

Steve Sayre Scholarship

Endowed scholarship established in 2010 with gifts from Katherine Brown Sayre '80 and her children in memory of their husband and father, Steve '80, a class agent for 30 years who had maintained strong ties with Gustavus friends and the Gustavus community. Designated for students who are "engaged in their community and church, show academic promise, maintain a cumulative GPA of 3.0, and embody the core values of Gustavus Adolphus College: excellence, community, justice, service, and faith," the scholarship "honors Steve's memory and hopes to inspire Gustavus students to grow and leave their own legacy."

Lorraine and Roland Scharmer Scholarship

Endowed scholarship established in 2000 by Lorraine E. and Roland D. Scharmer, who both graduated from the College in 1950 with degrees in mathematics and continued in their chosen field throughout their careers. It is designated for junior mathematics majors, with preference given "to students who are participating in work-study programs within the mathematics department or are mathematics tutors for first-year students, and who in their leadership and demeanor have shown themselves to embody the best of Gustavus spirit and character."

Lita and Jerome Schollmeier Scholarship

A current scholarship established in 2012 via transfer of stock by Merita Schollmeier '80, St. Paul, Minn., in honor of her parents, Lita and Jerome Schollmeier, and active for four years starting in the 2012–13 academic year.

Randal Schreiner and Cynthia Bittner Scholarship

Annual scholarship funded in 2005 by Randal Schreiner '78, Mahtomedi, Minn., and his wife, Cynthia Bittner, and administered through the Jussi Bjorling Music Scholarship program for organ students.

Edward H. Schultz Scholarship

Endowed scholarship established in 1991 by Edward H. Schultz of St. Peter, Minn., a lifelong friend of the College; it provides financial aid to students from rural areas or small towns, with preference given to students from the greater St. Peter area.

Roger Schwakopf Scholarship

Endowed scholarship established in 2001 by family and friends in memory of Roger Schwakopf '68, who was active with the alumni association and served as president of the alumni board in 1982–83. Reflecting Roger's business major and successful career in sales and marketing, the scholarship is designated for students in the Department of Economics and Management.

Securian Foundation Scholarship

Securian scholarships (formerly awarded as Minnesota Mutual scholarships) are awarded through the Minnesota Private College Fund to students majoring in business, economics, or mathematics. Securian Financial Group provides insurance and investment services to individuals and businesses.

Sehlin Grack Family Scholarship

Endowed scholarship established in 2009 with a pledge of current and future gifts from Sidney '61 and Virgene (Grack '61) Sehlin, in gratitude for "the quality education and opportunities provided to them because of their Gustavus education" and in the hope that scholarship recipients "will also learn the power of philanthropy and their own responsibility to extend help to the next generation of Gustavus students." It was active beginning 2012–13.

Dr. A.E. and Ruth Simonson Scholarship

Endowed scholarship established at three colleges in 1971 through the will of Dr. Simonson, with preference given to students from Pelican Rapids, Minn.

Alma Skinner Scholarship

Endowment established in 1998 by Dr. Alma Fogelberg Skinner, who attended Gustavus from 1926 to 1928, and was one of the first woman students from Gustavus to earn a medical degree. She had a strong interest in her Swedish heritage and was pleased to establish this scholarship through a bequest to assist students at Gustavus, specifically because of its ties to Sweden.

E. Terry Skone Scholarship

Established in 2002 by a bequest from E. Terry Skone '62 "to recognize and give appreciation for the education he received at Gustavus," with preference given to economics and management students; it has been active since 2008–09.

E. Terry and Lois L. Skone Scholarship

In 1997, Terry Skone '62 and his wife, Lois, mother of Sarah Lange '00, established the Student Investment Club at Gustavus to give students a "hands-on" opportunity to learn about and invest in the stock market. When the portfolio of the club exceeds a given level, the earnings are used as student scholarships, according to the College's established policies. Priority is given to students intending to major in the economics and management department, or who are planning careers in banking, finance, or entrepreneurship.

Lorraine and Edward N. Skone Scholarship

Endowed scholarship awarded to students majoring in economics or management; established as "a permanent expression of the fact that Gustavus Adolphus College has been and will be an integral part of the Skone family."

Sohre-Halverson Student Scholarship

Endowed scholarship established in 1985 through the will of Lloyd Halverson of Good Thunder, Minn., a member of the Sohre-Halverson family. His benefactions also include Sohre Hall and scholarship endowments that bear the names of Rose Sohre, Carl Sohre, Arthur Sohre, and Elsa Sohre Halverson, as well as a previous scholarship bearing Lloyd's name, which he had annually sustained from 1980 through 1985; the endowment has been combined with the above-named awards.

Kelly Jo Sorenson Memorial Scholarship

Endowed scholarship established in 1984 in memory of nursing student Kelly Jo Sorenson by her parents; awarded in cooperation with the faculty of the nursing department beginning with the 1985-86 term.

Southwestern Minnesota Synod International Student Scholarship Endowment

Endowed scholarship established in 1990 by the ELCA Southwestern Minnesota Synod to annually assist an international Lutheran undergraduate student.

Harold E. Sponberg Education Department Scholarship

Endowed scholarship established in 1975 by family and friends to honor the Sponberg family, and especially to honor Harold E. Sponberg '40, who distinguished himself in his career in higher education and encouraged his children to enter the education field as well; it is designated for students majoring in education.

Margaret Mallgren Stensvad Scholarship

Endowed scholarship established in 1998 by Margaret Mallgren Stensvad '36 and her family. It is designed to assist students who desire a Gustavus education and who need financial assistance to attend.

Axel and Loreli Steuer Scholarship

Endowment established in 2002 by friends of Axel Steuer, 13th president of Gustavus (served 1991-2002), and his wife, Loreli, "in recognition of the profound gratitude the Steuers have long expressed for the countless unknown others who made their educational pursuits financially possible, along with a deep affection for the students of Gustavus Adolphus College."

St. Paul Companies Inc. Urban Education Scholars

Funded through the Minnesota Private College Fund, St. Paul Companies annually provides grants to a select number of students of color attending the institutions affiliated with the Minnesota Private College Council who are majoring in education with an interest in working in an urban setting. The scholars must also commit to pursuing a summer community service job in an education setting with the St. Paul public and/or charter schools.

Strand Scholarship

Established in 2003 by Dr. Sherman O. Strand '42 and his wife, Ruth—both now deceased—and confirmed in 2010, the endowment is designated for pre-med students who have been accepted to the University of Minnesota Medical School.

Bert Sundberg Scholarship

Endowed scholarship established in 1952 through the estate of 1906 graduate J.E. Sundberg of Kennedy, Minn., and named in memory of his son Bert '39. The scholarship is restricted to students preparing for church vocations.

Surdna Foundation Scholarship

Endowed scholarship established by a grant from the Surdna Foundation and designated for students from rural areas.

Gerald D. and Julia E. Swanson Scholarship in Physics

Endowed scholarship established in 1989 by Gerald Swanson '62 and his wife, Julia, to honor the work of the physics department faculty who provided Gerald with a background that prepared him for graduate study in physics and for a career with the Bendix Corporation. It is designated for a senior student with demonstrated need and outstanding potential for graduate study.

Gordon Swanson Scholarship

Endowed scholarship established in 1986 by family and friends in memory of Gordon R. Swanson '52.

Kirsten D. and Heather A. Swanson Scholarship

Endowed scholarship established in 2006 (and updated in 2008) by Dawn Ekstrom Michael '67 in gratitude for her Gustavus experiences, including her leadership since her graduation as a class agent, Crown Council member, and member of Gustavus Library Associates; given in memory of her daughter Kirsten and in honor of Kirsten's twin sister, Heather. The scholarship is to be awarded with preference given to members of Our Savior Lutheran Church in Vero Beach, Fla., or permanent residents of Madeline Island, Wis.; if no student from either area is enrolled in any given year, it may be awarded in support of the Jussi Björling Music Scholarship program to any student for whom financial aid is essential in order to permit them to attend the College.

Kathryn Gustafson Swanson Memorial Scholarship

Established in 1986 by the family and friends of Kathy Swanson, with the first award given in the 1987-88 academic year. The scholarship is awarded to a sophomore, junior, or senior voice student who is a member of either the Gustavus Choir or Lucia Singers. Swanson was a member of the vocal music faculty at Gustavus who provided leadership and enthusiasm to vocal students.

Marian Helen Mellgren Swanson Scholarship

Endowed scholarship established in 2003 by Dr. Reuben Swanson '42 in memory of his wife, Marian Mellgren Swanson '40.

Honoring her career as a speech teacher at several high schools and colleges and also her service as an organist in several churches, preference is given "to Gustavus students who intend to major in English and/or have an interest in developing skills that may lead to becoming a church organist, or are involved in speech and/or debate"; it was first awarded for the 2003–04 academic year.

Roy and Colleen Swanson Scholarship

Established in 2000 by Roy Swanson and his wife, Colleen, longtime friends of Gustavus, to express their "gratitude for life and opportunity, and extend their work in helping prepare young men and women for leadership and service in the church and in society." The scholarship endowment will continue their legacy of support for students for generations to come.

Archie M. Swenson Music Scholarship

Endowed scholarship established by the Rev. Maurice '33 and Ruth (Swenson '32) Swenson, to honor Archie Swenson's long service as a church musician and teacher of piano.

Bennett Swenson Scholarship

Endowed scholarship established in 1995 by Marion V. Swenson in memory of her husband, Bennett Swenson '25, and to honor his life and career achievements as chief of the Hydrologic Services Division, U.S. National Weather Service.

Maurice and Ruth Swenson Scholarship

Endowed scholarship established in 2000 with gifts given by the Rev. Maurice and Ruth Swenson, their son and his wife, Ralph '61 and Marlys (Schneider '63) Swenson, and their daughter and her husband, Christine '63 and Thomas Wilmot. The scholarship honors Ruth, a member of the Class of 1932, and Maurice, Class of 1933, a Lutheran pastor for 35 years who worked in the Gustavus Food Service for another 18 years after retiring from the ministry. First awarded in 2003, it is designated for Minnesota students from low-income families who may struggle financially to attend college.

Ralph and Marlys Swenson Scholarship

Endowed scholarship established in 1998 by Ralph '61 and Marlys (Schneider '63) Swenson. It is awarded to high-need students who are U.S. citizens and for whom financial aid is essential in order to permit their attendance at the College.

Ruth M. Swenson Language Scholarship

Endowment established in 1990 by the Rev. Maurice Swenson '33 and his wife, Ruth Swenson '32, with the understanding that the remainder value of two annuities made with the College would be used after the survivor's death to fund the scholarship. Maurice died in 1999 and Ruth in 2002, and the remainders became an endowment for a scholarship designated for students who are studying in languages other than English and who are of junior standing or above, with selection of recipients made in the spring for awards for the following academic year; it was first awarded in 2003–04.

Swenson Heritage Scholarship

Endowed scholarship, formerly named the Emil and David Swenson Scholarship, honoring the memory of both the Rev. Emil Swenson, who served on the Gustavus Board of Trustees (1929–1955) and was president of the Augustana Minnesota Conference (1939–1955), and Wendell M. Swenson '42, Ph.D., a member of the Department of Psychology faculty (taught 1946–1959). This scholarship also honors the life and ministry of the Rev. David E. Swenson '70, who served on the Gustavus board, and is presented to Gustavus students who plan to attend the seminary and serve the church as their life work.

Paul S. and Mildred G. Swensson Scholarship

Endowed scholarship established by the family of Paul S. Swensson '28 and his wife, Mildred G. Swensson, and awarded annually, beginning in 1986, to an outstanding junior English major with journalism interests.

George and Ruby Taylor Scholarship

Endowment established by George and Ruby Taylor, longtime residents of Belle Plaine, Minn., and friends of the College; the scholarship is to be awarded to students with preference given first to residents of Belle Plaine, second to those of Scott County, and third to students from the state of Minnesota.

Gretchen and Brett Taylor Scholarship

Endowed scholarship established in 2007 with an outright gift from long-time College supporters Gretchen and Brett Taylor and the pledge of an addition gift from the Brett M. Taylor Jr. Charitable Remainder Trust, and first awarded for the 2010–11 year. Gretchen, a 16-year member of the College's Board of Trustees, was the recipient of the Alumni Association's highest honor, the Greater Gustavus Award, in 1992, and both she and Brett have served on the Parents' Committee as well. Two of their children, Nancy Zallek '82 and Mark Taylor '78, are graduates and three of their grandchildren are also Gusties.

Thalia and Larry Taylor International Scholarship

Annually sustained scholarship established in 2000 by the Taylors, who have been involved for many years as a host family for international students attending Gustavus. It is designated for international students for whom financial aid is essential in order to permit their enrollment, with preference given to students from Mexico, Thalia's homeland.

Sigrid Johnson Tegner Scholarship

Endowed scholarship established in 1974 by family and friends in memory of Sigrid Johnson Tegner '24.

Tennant Foundation Scholarship

Awarded starting with the 2005–06 academic year by the Tennant Foundation, and administered by the Minnesota Private College Fund; the scholarship is given to a student at each of the 17 MPCC-member private colleges and universities. The Tennant Company of Minneapolis is a world-leading manufacturer of indoor and outdoor cleaning solutions, specialty floor coatings, and floor-maintenance equipment.

Dr. Hulda E. Thelander and Hilding Thelander Scholarship

Endowed scholarship established with gifts from Dr. Hulda E. Thelander, friend of the College, during her lifetime and with her bequest provision. The scholarship honors the memory of Dr. Thelander and her brother, Hilding Thelander.

Henry and Harriet Thompson Scholarship

Endowed scholarship established in 1993 by Harriet Thompson, a friend of the College, to encourage students to attend Gustavus Adolphus College.

Arver and Eleanor Thorne Scholarship

Endowed scholarship established in 1994 by Arver Thorne '35 and his wife, Eleanor.

James R. Thorpe Foundation Scholarship

Funded by James R. Thorpe, son of Samuel S. Thorpe, co-founder of Thorpe Brothers Real Estate and past president of the company, and administered by the Minnesota Private College Fund; the scholarship is awarded to non-traditional students and students of color.

Andrew Thorson Scholarship

Endowed scholarship named for the Swedish immigrant farmer who, in 1873, worked to bring a college to St. Peter. Business people and other farmers supported Thorson's efforts with pledges of money and labor to realize his dream. Students from rural areas and small towns in the states of Minnesota, Wisconsin, Iowa, and North and South Dakota may qualify for this scholarship.

Thrivent Community Service Scholarships

Established in 2003 and awarded by the College through the Minnesota Private College Fund to students involved in ongoing community service, with preference given to business majors; recipients are to file a report of community service activities with Thrivent.

Thrivent Financial for Lutherans Foundation Lutheran College Scholarships

Awarded by the Thrivent Foundation to students based on high school academic records, leadership qualities, extracurricular activities, church and community involvement, and high school recommendations, and renewable contingent upon continued high achievement. Thrivent Financial for Lutherans was created in 2002 by a merger of Aid Association for Lutherans and Lutheran Brotherhood, both of which had made significant commitments to providing financial aid for students choosing to attend Lutheran colleges.

Dr. David L. Tilderquist Scholarship

Endowed scholarship established in 1945 by 1894 graduate Dr. David Tilderquist of Duluth, Minn., and restricted to natural science majors; it is normally granted once every four years to a first-year student.

Torrey Scholarship

Endowed scholarship established in 1996 by George B. Torrey '55, former member of the College's board of trustees (served 1993–2002); it is designated for students who are concentrating in accounting and/or finance, with a preference for students from rural Minnesota.

Robert E. and Katherine A. Tunheim Scholarship

Endowed scholarship established in 2010 by Assistant Professor of Economics and Management Katherine Tunheim and her husband, Robert, with annual gifts paid over five years, to be awarded with preference given to students majoring in management, entering their junior year, and coming from rural areas. The donors are providing annual funding for scholarships until the endowment matures.

Jeffrey Turrittin Scholarship

Endowed scholarship established in 2002 by John and Sally Turrittin of Medina, Minn., in honor of the life and well-being of their son Jeffrey '04. The Turrittins believe that a college education extends beyond the classroom, and their love of travel inspired them to establish a scholarship for students who wish to enroll in a Gustavus January Term study-abroad program, but for whom financial aid would be essential in order to permit them to participate.

Francis M. Uhler Scholarship

Endowed scholarship established in 1985 by Francis Uhler '24, who had been with the U.S. Fish and Wildlife Service for more than 60 years; the scholarship was awarded for the first time in 1986–87 and is designated for biology majors whose career goals are directed toward wildlife management or other environmental concerns.

UPS Foundation Scholarship

The UPS Foundation was established to carry out the social and charitable responsibilities of United Parcel Service in its role as a good corporate citizen. The Foundation gives priorities to adult literacy, distribution of prepared and perishable food, scholarship assistance to students of color, and educational and cultural gift-matching programs. Scholarships are designated through the Minnesota Private College Fund for one student of color per campus.

USBancorp Scholarships

Scholarships awarded each year without regard to a specific major, but to students of color attending private colleges. Distribution of the scholarships is coordinated by the Minnesota Private College Fund. (The scholarships were formerly known as First Bank System Inc. Scholarships before that Minnesota-based corporation merged with USBancorp.)

Frank W. Veden Scholarship

Endowed scholarship established in 1999 in the name of Frank W. Veden, friend of Gustavus Adolphus College, to be awarded annually by the College. The scholarship is designated for students from Otter Tail County, with first preference given to students from Fergus Falls, Minn. If a suitable recipient cannot be found in any given year, the funds may be awarded to any west-central Minnesota student demonstrating financial need.

Filip and Helen Vikner and Bernice Sundholm Family Scholarship

Endowed scholarship established in 2000 by Helen L. Sundholm Vikner '43 and her sister, Bernice I. Sundholm Norman, and designated for international students beginning in 2001–02, "especially those from China or other neighboring countries, for whom financial aid is essential in order to permit their attending Gustavus Adolphus College."

Elliott R. Wahlstrand Scholarship

Endowed scholarship established in 1990 by Estelle Wahlstrand Hendriksen '38, sister of Elliott Wahlstrand, to encourage students of high scholastic ability.

Florence Hanson Waits Scholarship

Endowed scholarship established in 1994 with a gift from the estate of Florence Hanson Waits '32 to provide scholarship assistance to students majoring in English, speech, or drama.

Courtney Walker Memorial Music Scholarship

Annually sustained scholarship established in 2005 and initially funded for four years by Dotta-Jo and Craig Walker and their children, Mitchell, Jordan, and Kaitlyn Walker, in memory of their daughter and sister, Courtney '02. Music and people were Courtney's passions throughout her life. The Walker family continues to fund the scholarship as a way to honor Courtney's passion and legacy. The scholarship is designated for a vocal performance student as part of the Jussi Björling Music Scholarship program at the College.

Wallin Foundation Scholars

Competitively awarded since 2002–03 to students of color from the Twin Cities area by the foundation established by Winston and Maxine Wallin of Minneapolis.

Clinton and Evelyn Walman Scholarship

Endowed scholarship established in 1983 by the parents of Susan Walman Engelbert '69.

Alf G. Watson Scholarship

Endowment established in 1998 with a bequest from Alf G. Watson, friend of the College, who emigrated from Sweden and found his home in Minnesota. The scholarship fund was initially designated to provide room, board, and one-half tuition each year to one male and one female student. In addition, the fund now provides significant need-based grants for several more students annually; for the 2012–13 academic year, three of the latter grants were awarded in addition to the two half-tuition scholarships.

Wells Fargo Foundation Scholarship

Wells Fargo Foundation, formerly known as the Norwest Foundation, is the charitable foundation of Wells Fargo, an \$80 billion company providing banking, insurance, mortgage, investment, and other financial services through more than 3,800 offices in all 50 states and internationally. The scholarships are awarded to junior and senior students from Minnesota through the Minnesota Private College Fund.

Mabel and Estella Wenstrom Scholarship

Endowed scholarship established in 1982 through the will of Estella Wenstrom and honoring Mabel Wenstrom '22.

West Publishing Scholarship

West Publishing is the country's leading publisher of law books, state statutes, and college textbooks. Scholarships are awarded through the Minnesota Private College Fund to students of color.

Ralph and Ruth Westlund Memorial Scholarship

Endowed scholarship established in 2008 with a gift given to the College by Ruth (Hanson '56) Westlund before her death in 2006. Ruth and her late husband Ralph Westlund '57 both valued the importance of a liberal arts education and held the belief that "Gustavus provides a culture that encourages and develops academic freedom and broad thinking to help students become leaders in their communities, churches, and careers."

Wiberg/Thompson Memorial Scholarship

Endowed scholarship established in 2006 by the children and grandchildren of Perley '26 and Bernice (Leadholm '28) Wiberg—sons Mark '58, Joel '60, Paul '69, and their families, and the children of Martha Lee Thompson '55 and their families—in memory of Perley, Bernice, and Martha, to be awarded to students for whom financial aid is essential in order for them to be able to attend Gustavus.

Sven Bernhard Widlund Scholarship

Endowed unrestricted scholarship selected by Gustavus.

Lea A. and Elsie L. Wildung Scholarship

Endowed scholarships established by Lea and Elsie Wildung, friends of Gustavus Adolphus College. The funds are awarded in the form of grants and scholarships.

Wilkinson Family Scholarship

Endowed scholarship from the estate of Ethel M. Wilkinson, intended to provide scholarships and stipends to students enrolled in the education curriculum who demonstrate "a genuine intent to pursue a career in teaching upon graduation." Recipients will be awarded scholarship monies in their sophomore year.

Marjorie Witman Scholarship

Endowed scholarship established in 1987 by Harold F. and Carole E. Witman to honor the achievements of their daughter Marjorie '72; it is designed to encourage students majoring in nursing.

Earl J. and Kathryn Fay Witte Scholarship

Endowed scholarship established in 1994 by Kathryn (Fay '29) Witte and the late Earl J. Witte '30 to encourage male students with demonstrated financial need to attend Gustavus Adolphus College.

Xcel Energy Foundation Scholarship

Awarded to students willing to commit to volunteering a minimum of two hours per week with an established community organization serving youth below ninth grade in a tutoring or mentoring capacity, and coordinated through the Minnesota Private College Fund. Xcel Energy, which was formed by the merger of Denver-based New Century Energies and Minneapolis-based Northern States Power Company (the scholarship had previously been awarded in NSP's name), is a prominent U.S. electricity and natural gas energy company serving more than 3.2 million customers with projects or offices in 25 states and 10 countries worldwide.

Doris Yokie Scholarship

Endowed scholarship for senior nursing majors displaying high academic achievement; it was established in 1985 to honor the former chair of the nursing department, the late Doris E. Yokie (taught 1963–1985), with the first recipient named for the 1985–86 school year.

Evelyn Sponberg Young Scholarship

Endowed scholarship established in 2000 by 1933 graduate Evelyn Sponberg Young, longtime director of the College's Food Service (1949–1981), in honor of speech professor Evan Anderson (taught 1924–1963), to recognize “the importance of speech and public speaking.” Preference is given to students intending to major in communication studies, which carries on the strong tradition of education in speech and public speaking.

Elizabeth Pearson Youngquist Memorial Music Scholarships

Endowed scholarships established in 2006 by Walter L. Youngquist '42 in honor of his wife, Elizabeth (Pearson '42) Youngquist. The scholarships, which are awarded through the Jussi Björling Music Scholarship program since 2007–08, are designated for students who have financial need and who have met the audition criteria, with priority given to those focusing on piano, cello, or organ, in that order.

Robert Eric Youngquist Memorial Scholarship

Endowed scholarship established in 2007 with a gift from Walter L. Youngquist '42 in memory and honor of his son Bobby, who was tragically brain-injured as a six-year-old. First awarded in 2008–09, the scholarship is designated for students who have overcome a physical or mental disability to be successful at Gustavus, “with the possibility of becoming productive citizens from the additional help of the Gustavus experience.”

Selma Knock Youngquist Memorial Nursing Scholarship

Endowed scholarship established in 2008 with a gift from Walter L. Youngquist '42 in memory of his mother, Selma R. Knock Youngquist, who attended Gustavus for two years before completing her nursing education at Swedish Hospital in Minneapolis and becoming a registered nurse; first active in 2009–10, it is designated for students intending to use their Gustavus nursing degree to pursue clinical practice and patient care.

Walter R. Youngquist Memorial Scholarship

Endowed scholarship established in 2007 with a gift from Walter L. Youngquist '42 in memory of his father, Walter R. Youngquist '16, who entered the savings and loan business in Minneapolis after serving in World War I and eventually became president of First Federal Savings and Loan, expanding it to a \$160 million organization. He continued to support Gustavus, establishing and raising funds for the Greater Gustavus Endowment Corporation, serving on Gustavus's board of directors, and providing an early gift to establish the College's arboretum. Honoring his persistence against considerable odds, scholarship awards were first made in 2008–09 and take into consideration the qualities of dependability, persistence, and stability in personally adverse circumstances. “These qualities may be more important to success in later life than simply academic excellence. Therefore, scholarship is important, but is not to be the primary criterion in awarding these funds.”

Youngquist Strand Legacy Scholarship

Endowed scholarship established in 2012 with a significant cash gift given to the College by Marold Strand '52 in memory of his wife, Jeanne Youngquist Strand '52; Jeanne's parents, Selma Knock Youngquist '17 and Walter Youngquist Sr.'17; and Marold's parents, Naomi and Clarence Strand. The scholarship, active in 2012–13, is “a tribute to their lives and the role Gustavus Adolphus College has played in the family's legacy.”

Recently Established Scholarships

Denny Aguiar Scholarship

Endowed scholarship established in 2012 with cash gifts by Dennis J. Aguiar '67, Leawood, Kan., “in honor of legendary coach Don Roberts (served 1959–1997), who recruited, coached, and mentored Aguiar during his four years at Gustavus and continues to be a lifelong friend.” It is designated for students “who are well-rounded individuals as a result of their involvement in co-curricular activities.”

Class Scholarships

Several College classes have established endowed scholarships to mark milestone anniversaries of their graduation. Below are class scholarships established during the current academic year.

- the Class of 1961, established in 2012;
- the Class of 1973, in 2013;
- the Class of 1988, in 2013;
- the Class of 2010, in 2012, anticipating the fifth anniversary of their graduation.

Federated Insurance Accounting Scholarship

Annually sustained scholarship funded with an annual cash gift and first awarded during the 2012–13 academic year. Preference is given to “students majoring in accounting, who have a cumulative GPA of 3.5 or higher, are in their sophomore, junior, or first semester of their senior year, and who have demonstrated community service or hold leadership positions in co-curricular activities.”

The Rev. Bernhard and Evelyn Nordstrom Johnson Scholarship

Current scholarship established in 2013 in memory of the Rev. Bernhard '39 and Evelyn Nordstrom '40 Johnson by their daughter, Siri Johnson Quitmeyer, and her husband, John Quitmeyer, with a cash gift. A tribute to the Johnsons' ministry and service to the Lutheran Church, it is designated for third- and fourth-year students planning to enter the Lutheran ministry.

Jeanne and Ernie Lindstrom Scholarship

Established as an annual scholarship in 2003 for a 10-year period by Jeanne Turnquist Lindstrom '59 and her husband, Ernie, and endowed in 2012 with an outright gift from the Lindstroms. The scholarship is designated for students who are majoring in elementary education.

Mansergh Award

Endowed awards established in 2007 as the Gordon Mansergh Scholarship with gifts from Mansurgh, a 1984 psychology graduate who was the founding director of the Wellness Center at Boston University and since 1995 has worked with the U.S. Centers of Disease Control and Prevention (CDC), most recently as senior behavioral scientist in the Division of HIV/AIDS Prevention. Renamed the Mansergh Awards in 2011 and active at that time, they facilitate credited experiences of junior or senior Gustavus students involved in internships (January IEX internships and otherwise) in U.S. federal agencies that address public health issues. The Provost's Office shall oversee the selection of each year's Mansergh Award recipients, with input from appropriate academic departments and faculty.

James and Winnabeth Neeck Scholarship

Endowed scholarship established in 2012 by Jim and Betsy Neeck in celebration of the music ensemble performances they have shared and enjoyed with their daughter, Jackielynn Peterson '77, and in honor of their granddaughter Kaitlyn Marie Peterson '11, a studio art major. The scholarship is designated for students pursuing degrees in either music or studio art, to alternate between those two departments on a yearly basis.

Corby and Mary Enstad Newman Scholarship

Endowed scholarship established in 2012 by Corby Newman of Willmar, Minn., in honor of his late wife, Mary Enstad Newman '59. Both were longtime teachers in the Willmar school district, and this scholarship is designated "to help students pursuing degrees in education follow their dreams and instill a lifelong passion for teaching and learning."

Helen C. and Carolyn C. Onufrak Scholarship

Endowed scholarship established in 2013 through a provision of her estate by Helen Onufrak '80, Arlington, Va., a junior transfer welcomed by the Gustavus community. The scholarship's title also honors her mother, Carolyn Onufrak, "who was instrumental in providing financial support that allowed Helen to attend Gustavus." It is designated for students who are from a state other than Minnesota and/or are transfer students.

Lee and Virginia Petersen Scholarship

Endowed scholarship established in 2012 with a significant gift from Ginny Hendrickson Petersen '67 and her husband, Lee Petersen '68, of Spring, Texas. Lee, a biology and geology major, earned advanced degrees and has had a distinguished career as a petroleum geologist; Ginny majored in biology and, after interning in medical technology during her senior year, was a longtime medical technologist. In addition to establishing this scholarship, the couple simultaneously funded two other endowments: a scholarship in honor of emeritus geography professor Robert Moline (taught 1961–1998; see below), and a fund in honor of emeritus geology professor Keith "Joe" Carlson (taught 1966–2002—Lee was one of his first students) to support student and faculty research, student activities, field trips, etc. in the Department of Geology.

Lee and Virginia Petersen Scholarship in Honor of Robert Moline

Endowed scholarship honoring emeritus geography professor Robert Moline (taught 1961–1998), established in 2012 with a gift from Ginny Hendrickson Petersen '67 and her husband, Lee Petersen '68, of Spring, Texas. In addition to establishing this scholarship, the couple simultaneously funded two other endowments: another scholarship (see above), and a fund in honor of emeritus geology professor Keith "Joe" Carlson (taught 1966–2002) to support Geology Department activities.

Lita and Jerome Schollmeier Scholarship

A current scholarship established in 2012 via transfer of stock by Merita Schollmeier '80, St. Paul, Minn., in honor of her parents, Lita and Jerome Schollmeier, and active for four years starting in the 2012–13 academic year.

A.J.N.M. Tolzmann Scholarship

Endowed scholarship funded with gifts from the Rev. Arlyn Tolzmann '65 and his wife, Jeanne Mingus Tolzmann '67, of Elgin, Ill. The scholarship honors Arlyn, Jeanne, and their two sons, Nathan '92 and Matthew (A.J.N.M. in the endowment fund's title), and is designated for students from outside of Minnesota who plan to pursue a degree in art, music, or education.
