**Friday, January 24 & Saturday, January 25**  
**Overnight flights to Malaysia**

Routing and schedules to be determined in the first quarter of 2019

**Sunday, January 26**  
**Welcome to Malaysia**

Upon arrival in Kuala Lumpur, meet your local tour manager and transfer to the hotel to freshen up for welcome dinner in a local restaurant. (D)

**Monday, January 27**  
**Kuala Lumpur & Batu Caves**

Kuala Lumpur is Malaysia's capital, as well as its financial and cultural center. A guided tour of the city center and nearby Perdana Botanical Garden includes seeing the King's Palace, Independence Square, the National Mosque, the Old Railway Station, the National Monument, and a visit to the iconic Petronas Twin Towers.

Free time for lunch on own, then visit Batu Caves, a mountainside Hindu Shrine whose limestone formations were dedicated as a temple in the late 10th century. The largest cave, Cathedral Cave, is accessed by 272 steep stairs rising over 300 feet from the entrance. Return to Kuala Lumpur for dinner on own, then

consider a visit to a local night market, a section of one of the city's residential neighborhoods around the city that are closed to traffic after the workday ends in order to allow for endless stalls of merchants selling produce street food, clothing, household items, and more. (B)

**Tuesday, January 28**  
**Islamic Arts Museum**  
**Kuala Lumpur Performance**

Today, the ensembles will visit a local school for an exchange performance. Outside of the performance time, take a guided visit to the Islamic Arts Museum, which is the largest museum of its kind in Southeast Asia. Its twelve galleries explore art, architecture, manuscript, arms, jewelry and more. Use any additional time to explore Kuala Lumpur on own, then re-assemble for a group dinner, with a visit to the Kasturi Walk and Central Market to peruse Malaysian arts and crafts. (B,D)

**Wednesday, January 29**  
**George Town, Penang**

Check out of the hotel and transfer to the island of Penang in the northern region of Malaysia. Upon arrival, have lunch on own, then embark on a guided city tour of George Town to see the Queen Victoria

Clock Tower, Fort Cornwallis, City Hall, St. George's Church, Cheong Fatt Tze Mansion, Leong San Tong Khoo Kongsi Mansion, and Market Street. Check into the hotel and have dinner in a local restaurant. (B,D)

**Thursday, January 30**  
**Penang Hill**

Ascend Penang Hill for amazing views of the Strait of Malacca from the Sky Deck. Return to George Town for lunch on own, followed by a George Town Street Art Tour and entrance to the Pinang Peranakan Museum, a furnished mansion recreating the style of the Straits Chinese heritage. Dinner in a local restaurant. (B,D)

**Friday, January 31**  
**Tropical Spice Garden**  
**Penang Performance**

Morning at leisure to explore George Town on own. While the ensembles prepare for the day's performance, take an excursion to the Tropical Spice Garden, a natural valley home to over 500 species of herbs, spices, and tropical plants. Here, a resident chef will lead a hands-on cooking class of traditional family recipes. Return to George Town for the performance and dinner in a local restaurant. (B,L,D)



**Saturday, February 1**

**Transfer Day**

Check out of the hotel and transfer to Malacca (approximately 7 hours), with stops en route including lunch in a local restaurant. After arriving in Malacca, check into the hotel and freshen up for dinner in a local restaurant. (B,L,D)

**Sunday, February 2**

**Malacca Tour**

Enjoy a free morning to explore Malacca on own or attend church services. After lunch on own, take a guided tour exploring the diverse history of Malacca. See A'Formosa, St. Paul's Church, Porta de Santiago, Cheng Hoon Teng Temple, Hang Li Poh's Well, the Stadthuys, Christ Church, and visit the Baba Museum. Dinner in a local restaurant. (B,D)

**Monday, February 3**

**Traditional Batik**

**Malacca Performance**

The ensembles will again visit a local school for an exchange performance. During their rehearsal time, visit the striking Malacca Straits Mosque. This striking building blends architectures from both the Muslim and Malay traditions, and sits on a man-made island. Its 100-foot tall minaret doubles as a working lighthouse, guiding boats and aircraft near the strait.

Rejoin the ensembles for their performance, then transfer together to

Melaka Nyonya Village for a specially-prepared local Kampong Lunch.

Afterwards, learn about the traditional fabric, batik, and dye your very own batik to take home. Dinner at a local restaurant this evening, followed by a visit to a Malacca night market. (B,L,D)

**Tuesday, February 4**

**Singapore Tour**

Check out of the hotel and transfer to Singapore, stopping to clear immigration at the border. Drop the bags at the hotel and have lunch on own before embarking on a city tour. See Victoria Concert Hall, Padang Cricket Pitch, National Art Gallery, the War Memorial, and the Merlion. Take a group photo at the Merlion, a statue of the mythical creature with the head of a lion and the body of a fish, which has become a recognized symbol of Singapore. (B)

**Wednesday, February 5**

**School Visit & Exchange**

**Culture Walk & Night Safari**

Join the ensembles on their morning visit to a local school for musical exchange and performance for the school cohort. Learn about the education opportunities in Singapore and enjoy lunch in the school canteen.

Take an afternoon tour highlighting the culinary culture of Singapore, including the Nanyang Coffee Factory and make-your-own Popiah Skin spring rolls. Enjoy a Hainanese Chicken Rice dinner, then

transfer to the world's first nocturnal zoo, the Singapore Night Safari. (B,L,D)

**Thursday, February 6**

**Dignity Kitchen, Esplanade, & Super Trees**

Morning visit to Dignity Kitchen, Singapore's first hawker center run by challenged and disadvantaged persons. Learn about the history of the enterprise and interact with the staff that works the stalls, then enjoy their craft with a provided lunch coupon.

Transfer to the ensembles' public performance along the Singapore River at the Esplanade. Free time follows, before meeting in the Gardens-by-the-Bay for dinner and the nightly Light Show at the Super Trees. (B,L,D)

**Friday, February 7**

**Day at Leisure**

Full day at leisure with the option to join a half-day MacRitchie Tree-Top Walk, which features a 250m free-standing suspension bridge that connects two of Singapore's highest points. Gather for a farewell dinner featuring the traditional Peranakan dish, Laksa, which is a spicy rice noodle soup. (B,D)

**Saturday, February 8**

**Flights to USA**

After breakfast at the accommodation, the day is free and flexible until the transfer to the airport for the return flights to the USA (time to be determined). (B)

These are the terms and conditions (“Terms”) under which we offer Accent Concerts tours. By registering and paying your deposit for a Tour, you are entering into this Participant Agreement with us. Please read these terms carefully before making a deposit or payment for a Tour. These Terms may be supplemented by additional terms and conditions specific to your Tour (“Supplemental Terms”). In the event of a conflict between this agreement and the Supplemental Terms, the Supplemental Terms will apply.

## Accent Concerts Participant Agreement

Accent Concerts acts only as the trip organizer, and is not responsible for the acts or omissions of other parties. The trip described on the Accent Concerts website (the “Website”) or in your brochure (the “Tour”) may include services provided by one or more independent operators or service providers (each, a “Supplier”). Accent Concerts may be referred to herein as “we” or “us.” Each traveler registered for a Tour is referred to herein as a “Participant” regardless of whether the traveler registers with us directly or through a parent, guardian or other party. The terms and conditions of this Participant Agreement apply to your Tour and the program for the Tour (the “Itinerary”).

## Pricing and Inclusions

Quoted Tour prices are specified in the brochure and vary according to the type of tour, hotel occupancy, and other options you select. Prices include programming, planning, handling and operational charges and are based on current rates of exchange, airfare and fuel surcharges, tariffs and taxes in effect at the time of publication. We reserve the right to increase Tour prices to cover increased costs, fuel surcharges, tariffs, and taxes received after prices are published and to reflect fluctuations in foreign exchange markets. We will notify you of any such additional costs as soon as practicable after we become aware of them.

## Exclusions

Quoted Tour prices exclude: trip insurance; transportation to and from the Tour; baggage fees, including excess baggage charges, charged by airlines; rental of musical instruments or other equipment; ground transportation other than by passenger motorcoach; costs associated with obtaining passports or entry visas; airport departure taxes (unless otherwise noted); meals not specifically identified on the Website or in your brochure; meals and beverages other than those specified in the Itinerary; sightseeing not included in the Itinerary; personal expenses and optional activities (which are subject to availability).

## Reservations and Payments

The Initial Deposit amount required for the Tour is listed in your digital booking form. The Initial Deposit is required in order to confirm your booking and is nonrefundable. Upon receipt of the deposit, we will send you confirmation of your booking. The installment payments will be due on the dates specified in your digital booking form. Final payment is due sixty (60) days prior to departure unless otherwise indicated on the digital booking form. If a Tour is already full, we may accept deposits on a standby basis. If space becomes available, you will have the choice of joining the Tour by paying in full or forfeiting the space in return for a refund of your deposit. If your reservation is made within sixty (60) days of departure, the entire cost of the trip must be paid at the time of the request in order to secure confirmation. **NOTE: Many rates provided by third party providers are locked in only for a specified period of time. Therefore, late payments may result in additional fees or cancellation of your reservation.** The stated price of the tour is based on cash-equivalent payments. Payments by credit

card may be assessed a processing fee as permitted by our merchant service agreement, and any such processing fee will be clearly disclosed. You agree to not dispute any credit card charges associated with this Tour as specified on the Website, in your brochure or in these Terms.

## Child Discount

We may offer cumulative child discounts for families registering on certain Tours with multiple children, as specified on the Website or in your brochure. Children must be 10 years old or younger to and a member of the registrant’s immediate family to qualify for the Child Discount.

## Travel Protection Insurance

You will have the option of purchasing trip cancellation and medical insurance. This insurance helps protect your investment in the event you must cancel in the Tour and also provides certain medical coverage while you are outside of the United States. We will provide the insurance applications along with your booking confirmation. Any questions about the terms of your coverage, what travel insurance does or does not cover should be addressed directly to the travel insurance company.

“Cancel For Any Reason” coverage (“CFAR”) is available for purchase and should be considered because we strongly adhere to the cancellation policy specified in your brochure, on our Website and below. CFAR can refund seventy-five percent (75%) of the refundable amount you have paid toward the Tour. If you decline insurance coverage, you will personally assume full responsibility for any financial loss associated with your travel arrangements, and you could lose your travel investment and/or have to pay more money to correct the situation.

## Cancellation by You

We must receive your cancellation notice in writing by email, fax or overnight courier, and your cancellation date will be the date on which we receive your notice. Penalties will apply as specified in your signed registration form. Your decision not to participate on the Tour due to State Department warnings, fear of travel, illness or any other reason will be deemed a cancellation. If a flight or other delay for any reason prevents you from joining the Tour on the Tour departure date and time, you will be considered a no-show, and we cannot provide a full or partial refund or credit toward a future Tour; however, you may join the Tour late if agreed to in writing by us.

## Air Transportation during the Tour

Airfare costs and availability are subject to change at any time prior to final payment for your Tour and may result in an increase in the Tour price or a modification of the itinerary. We will notify you of any such change as soon as practicable. Airlines often change seat assignments to satisfy their loyalty members or because of equipment changes (aircraft type). We are not notified of these changes in advance, and often travelers are not made aware of these changes until they arrive at the airport. We cannot be responsible for seat assignment changes made by the airline.



Frequent flier programs are private agreements between airlines and passengers, and we cannot be held responsible for mileage discrepancies involving airline loyalty reward programs. Each Participant is responsible for complying with all applicable airline requirements, including baggage requirements and hazardous materials prohibition.

#### **Passports and Visas**

You are solely responsible for complying with passport and visa requirements as applicable. International travel requires a passport valid six (6) months beyond your intended return travel date. Please apply for your passport immediately due to the amount of time it may take to process your passport application. In many cases, you will also need to have multiple consecutive blank visa pages within your passport (the number varies depending on the destination(s)). Many destinations also require that visas be obtained prior to travel. It is recommended that you check with the U.S. Department of State [website](#) for the latest passport and visa requirements. You must have your passport in your possession at all times while on your Tour. **You must also provide us with a copy of the inside page of your passport (showing your name and photo) at the time of reservation and in no event less than 90 days prior to departure.**

#### **Hotel Swimming Pools**

Hotels utilized on the Tour may have swimming pools. Some hotels provide lifeguards for certain hours and some do not provide them at all. **Under NO circumstances may a minor swim in a hotel pool when a parent, guardian or lifeguard is not physically present at the pool.** Any such swimming is a violation of these Terms and is undertaken at the sole risk of the traveler. We are not responsible for death or Injury occasioned while a minor is utilizing a hotel pool or pool facilities, whether or not a parent, guardian or lifeguard is present.

#### **Cancellation or Substitution by Us**

We will make commercially reasonable efforts to keep the Itinerary as it has been published; however, the final Itinerary may vary due to availability and factors beyond our control. We may in our sole discretion substitute services such as hotels or goods of similar quality for any service or good stated in the Itinerary.

We reserve the right to cancel any Tour in our sole discretion because of inadequate enrollment that makes the Tour economically infeasible to operate or because of our concerns with respect to the safety, health or welfare of our travelers or staff. If we cancel a Tour, our liability is limited to a full refund of your payments to us and we will not be liable for any other costs, damages or refunds of any kind for any loss, delay, inconvenience, disappointment or expense whatsoever in such circumstances. #### **Other Taxes and Fees Related to International Travel**

#### **Unused Services; No Partial Packages**

No refund will be made for any unused services, including airfare purchased as part of a package tour.

#### **Suppliers Acts or Omissions**

You hereby expressly assume all of these risks and dangers, and you hereby expressly agree to forever release, discharge and hold us and our agents, employees, officers and directors, harmless against any and all liability, actions, causes of actions, suits, claims and demands of any and every kind and nature whatsoever which you now have or which may hereafter arise out of or in connection with your Tour or participation in any activities in which you participate.

#### **Governing Law and Waiver of Trial by Jury**

These Terms will be interpreted under and governed by the laws of the State of Arizona. The parties agree to make all reasonable attempts to resolve any claim or dispute arising out of or relating to Accent Concerts, a Tour, or these Terms prior to the initiation of any further action. If the parties are unable to

reach a resolution of the dispute, the parties may proceed to litigate the matter. Any legal action by any party shall be brought exclusively in the Maricopa County, Arizona Superior Court or in the United States District Court for the District of Arizona. By indicating your acceptance of these Terms you knowingly, voluntarily and irrevocably: (i) consent to the exclusive jurisdiction of Arizona courts; (ii) waive any immunity or objection, including any objection to personal jurisdiction or the laying of venue or based on the grounds of forum non conveniens; (iii) waive any personal service of any summons, complaint or other process that may be made by any other means permitted by the State of Arizona; (iv) waive any right to trial by jury and agree that any such dispute will be decided by court trial without a jury.

#### **Health Requirements and Activities, Medical Conditions and Special Assistance**

Some of our Tours incorporate or require activities such as walking, hiking, stair climbing and the like; you are responsible for familiarizing yourself with the level of activity that will be involved in your Tour. You must disclose in your Participant Information Form (or at such later time when you become aware of such a condition) any existing physical or mental illness, disability, pregnancy or any other condition or limitation. We will make reasonable efforts to accommodate your needs, but you must notify us at the time of booking for a determination of what assistance we can reasonably provide. Many Tours may not be wheelchair accessible and may not be suitable for motorized scooters, walkers, and canes. If we cannot accommodate your special needs, you must be accompanied by a companion who will be responsible for independently providing the needed assistance. In no instance will our Suppliers or we physically lift or assist you on to or off any vehicles.

We reserve the right to decline acceptance of anyone we consider unsuitable due to fitness level. We also reserve the right to remove you from the Tour, at your own expense, if your condition is such that it could create a hazard to you or others, or otherwise impact the enjoyment of other passengers. If any Participant is removed from the Tour due to health reasons beyond the Participant's control, our only obligation is to refund to that Participant that portion of the payment allocable to unused services. If any Participant is removed from a Tour due to the Participant's violation of these Terms, we are not obligated to offer any refund.
